INTRODUCTION

Les documents du très honorable Charles Joseph Doherty constituent une excellente source d'information sur l'histoire canadienne du XIX^e et du XX^e siècle. Ils traitent de sa carrière professionnelle et personnelle à titre d'étudiant, d'avocat, de juge et de ministre. Par la richesse de l'information, ce fonds d'archives apporte une contribution importante à notre mémoire collective. Le présent inventaire reflète cette documentation unique.

Nous tenons à remercier Nicole Blain pour sa participation au traitement du fonds d'archives.

Nous avons divisé le fonds d'archives en 3 séries. Elles correspondent aux étapes de la carrière et des activités personnelles de Charles Joseph Doherty à partir de ses études jusqu'à ses activités à la Chambre des communes.

L'inventaire regroupe intellectuellement les volumes et les dossiers de différentes dimensions et de différents supports.

Nous avons indiqués les titres des séries et des sous-séries en français et en anglais. La description de dossiers est faite dans la langue de la majorité des documents inclus dans les dossiers. La plupart des documents sont écrits en français et en anglais.

The papers of Right Honourable Charles Joseph Doherty provide a rich source of information about Canadian history of the XIXth and XXth century. There are documents concerning his professional and personal career as a student, a lawyer, a judge and a Minister. The papers make an important contribution to the collective memory of Canada. The following inventory details this unique documentation.

We would like to thank Nicole Blain for her participation in the control work and in the preparation of the inventory.

We have divided the fonds into 3 series. They follow the stages of his career from his studies to his activities at the House of Commons. The inventory regroups intellectually the volumes and files of different size and medium.

The titles of series and sub-series are written in Canada's two official languages. The description of the files was done in the language of the majority of documents included in the files. Most of the records are written in French and in English.
