INTRODUCTION

The James Duncan Hyndman fonds was acquired in 1972 and an addition was made in 1994. These two accessions have now been integrated. This fonds consists of documents from his career as judge of the Supreme Court of Alberta (1914-1931) to chairman of the War Claims Commission (1953-1959).

The correspondence is arranged alphabetically, the way it was received in 1994. This order was kept even though this arrangement does not seem to be original. The majority of the correspondence is from the 1930s. Multiple letters from the same correspondant are arranged chronologically.

The recommendations of the Appeals Against Internment have been arranged by case number. There is a master list (vol. 14, file 41) with the names of the internees arranged alphabetically accompanied by the case number. The Notes on Hearings have been kept in their original order. All these notes seem to be arranged by case number and location of the hearing. Here the master list can also be used as a guide.

A separate series was created for the Naturalization Act. It is not known exactly why Justice Hyndman had these documents and in what context he possessed them.

The Recommendations of the War Claims Commission are arranged chronologically. No list could be found with the names and case numbers. Unfortunately many of these recommendations have no date.
