Administrative History

The Canadian Bar Association was founded in 1914 and incorporated in 1921. The objects of the association are to advance the science of jurisprudence, promote the administration of justice and the uniformity of legislation throughout Canada. It also upholds the honour of the profession of law, fosters harmonious relationships and social intercourse among members of the Canadian Bar and encourages a high standard of legal education, training and ethics. It also publishes its own transactions, as well as reports of cases and information and discussions concerning the law and its practice.

Scope and Content

The fonds consists primarily of the files of past presidents of the Canadian Bar Association, including Sir James Aikins, 1911-1917, 1924; Arthur Norwood Carter, 1947-1967; Paul Phelps Hutchison, 1955-1956; Everett Clayton Leslie, 1956-1957; Arthur Kelly, 1954-1959; Walter Stewart Owen, 1955-1965; Renault St-Laurent, 1957-1963; Stanley Elmer Fennell, 1951-1965; John L. Farris, 1960-1974; and E. Neil McKelvey, 1967-1975.

In addition, the fonds includes printed material, and portraits of Canadian and British judges and lawyers and members of the Canadian Bar Association.

Presented in 1973 and 1976 through Mr. R.C. Merriam, Executive Director, Canadian Bar Association, Ottawa, Ontario. Additional material was acquired in 1997 from Diane Sawyer of Aylmer, Quebec.
