Duncan Gordon Blair, born in 1919 at Regina, Sask., was educated at the University of Saskatchewan and at Oxford University as a Rhodes Scholar in 1941. He saw action with the Irish Regiment in Italy, and was seriously wounded in May 1944. Blair, an Ottawa lawyer, served as an officer of the constituency, provincial and national organizations of the Liberal party in various capacities over a number of years. From 1964 to 1968, he was President of the Liberal party in Ontario and he sat as Member of Parliament for Grenville-Carleton from 1968 to 1972. In 1976 he was appointed to the Ontario Court of Appeal.

Justice Blair was president of the Canadian Section of the International Commission of Jurists from 1973-1976. He was Chairman of the Constitution and Laws Committee of the Royal Canadian Legion from 1976-1986. He was founding member of the Canadian Judges' Conference and was chairman of that organization from 1983-1984, after which time he remained a member, and was active on the compensation and nominating committees.

The papers are divided into nine main series including Parliamentary papers, 1968-1975, 4.300m, and Liberal Party material concerning the National, provincial and local levels, 1954-1973, 2.300m.

Papers relating to three organizations with which Justice Blair was closely involved: the Canadian Section of the International Commission of Jurists, the Canadian Judges' Conference and the Constitution and Laws Committee of the Dominion Command of the Royal Canadian Legion. There are both copies of outgoing correspondence and originals of correspondence received for each of the three organizations, as well as various subject files.

Material relating to Blair's term of office as a member of parliament representing Grenville-Carleton, 1968-1972. Files either relate to constituents and topics of local interest, or to the duties and interests of Blair in the House of Commons.

Arranged alphabetically.

Finance White Paper. Original, 1969-1971, 0.200 m. (Vol. 13).

Correspondence, reports, and reference materials, arranged alphabetically by nominal title.

Arranged alphabetically by topic.

Arranged alphabetically in nominal subject files, based on Blair's original titles.

Local Liberal Organization. Original, 1968-1972, 0.400 m. (Vol. 32-33).

Concerning Grenville-Carleton and Vicinity, arranged alphabetically by topic.

Canadian Judges' Conference - Correspondence. Original, 1979-1987, .400 m. (Vol. 34-36).

Correspondence, mostly copies of outgoing letters, concerning the Canadian Judges Conference. Most of the correspondence is with other judges, some is with politicians and lawyers.

Canadian Judges' Conference - Chairman's Papers. Original, 1979-1987, .600 m. (Vol. 36-39).

Alphabetical subject series of topics which concerned Blair during his term as Chairman of the Canadian Judges' Conference. Many of the files were added to after his term. There is also some material which he received from past presidents. Topics include: the constitution committee, finances and the Deschenes inquiry.

Canadian Judges' Conference - Compensation Committee. Original, 1983-1990, .360 m. (Vol. 39-40).

Papers of the compensation committee, which address the issues of judges' salaries and pensions. Includes correspondence, clippings, drafts and reports.

Canadian Judges' Conference - "Important Documents". Original, 1982-1990, .160 m. (Vol. 41).

The contents of two binders of significant committee reports, submissions to parliamentary committees and analyses of issues pertaining to judges and the legal system.

Canadian Judges' Conference - Later Subject Files. Original, 1980-1988, .240 m. (Vol. 41-42).

Files began after Blair's term as president, which are less formally organized. Topics include: reports to the executive, pensions and insurance.

International Commission of Jurists. Original, 1974-1982, .400 m. (Vol. 43-44).

Correspondence, international reports on human rights and access to justice, records of various trials and notes on various international conferences.

Royal Canadian Legion - Dominion Command. Original, 1973-1989, .560 m. (Vol. 45-47).

Letters, notes, reports and drafts documenting Blair's involvement with the Constitution and Law's Committee of the Dominion Command. Includes many letters showing Blair's interest in the affairs of individual veterans, as well as clippings. The files have been maintained in Justice Blair's original order.
