INTRODUCTION

R. Lou Ronson was born in Toronto on 21 February 1915. A graduate in chemical engineering from the University of Toronto and the Lawrence Institute of Technology in 1938, he began his career in the dry cleaning industry in 1939. During World War II he was on active service from July 1943 to November 1945. He was a sergeant instructor in an army school for NCO's. After the war he returned to the dry cleaning industry and rose to the position of President and Chief Executive Officer of Sunshine Uniform Supply Co. Ltd. in 1970. Following a merger with twelve other companies, he assumed the presidency of Work Wear Corporation in 1975. From 1982 until his retirement in 1987 he served as Chairman of the Board. He is also a director and chairman of the audit committees of the Bank Hapoalim (Canada) and the Constitution Insurance Company of Canada.

Lou Ronson has been a life-long member of B'nai B'rith, District 22. He first joined Toronto Lodge in 1939. He rose through the organization serving one term as president from 1979-1980. Currently he is a member of the executive committee of B'nai B'rith International and national archives chairman of B'nai Brith Canada. He was instrumental in separating various Canadian regions which were segments of various American districts into one national Canadian district. He first joined the Anti-Defamation League (ADL) in 1956 and played a major role in its growth and development. Renamed the League for Human Rights (LHR) in 1970 he served as its National Chairman from 1974 to 1975. The LRH's *Annual Review on Anti-Semitism in Canada* is funded from the R. Lou Ronson Research Institute on Anti-Semitism. A proponent of harmonious Christian-Jewish relations, in 1973 he led the negotiations which resolved the bitter dispute between B'nai B'rith, District 22 and the United Church of Canada over its controversial editor, the Rev. A.C. Forrest and *The Observer*.

Lou Ronson was an active member and past chairman of the Joint Community Relations Committee of the Canadian Jewish Congress and B'nai B'rith, Ontario Region from 1960 until its demise. For his dedicated humanitarianism he was appointed to the Ontario Human Rights Commission in 1985 and made Vice-Chairman in 1986.

Lou Ronson has been associated with many community service organizations and institutions in various executive capacities. They include the Mount Sinai Hospital of Toronto since 1976, the Jewish Community Centre of Toronto, National Co-chairman of the Canadian Council of Christians and Jews since 1977, president of the Canada-Israel Chamber of Commerce and Industry and the Canada-Israel Committee, 1967-1980, vice-president of the Canadian Technion Society, national board member of Canadian Friends of Haifa University and on the national executive of the Canadian Jewish Congress, 1971-1982.

RESEARCH POTENTIAL

There is much research potential in this collection for students interested in studying Jewish communal organizations, institutions and their community leaders who were involved in the decision-making process after 1960. Some are Toronto-based institutions such as Mount Sinai Hospital while others operate at the national level such as B'nai Brith Canada and the inter-denominational Canadian Council of Christians and Jews. Researchers will gain insights into their activities and the nature of their work. The R. Lou Ronson papers were donated to the National Archives of Canada in 1985 and 1987. Lou Ronson's papers were arranged into series which are listed in the Table of Contents. Each organizational series contains reasonably complete files of minutes of meetings, memoranda, near print and other publications and correspondence. Thus, a researcher can get a fairly good illustration of each body's internal operations. Some of the series are especially noteworthy. For example, the National Joint Community Relations Committee, sponsored in part by B'nai Brith, District No. 22 was involved in combating indigenous race hatred groups such as the Western Guard and their racist propaganda. As well, Ronson has created a set of files which chronicle the Committee's origins up to the time of its dissolution in the early 1980's. Ronson's role to preserve the Committee is detailed. B'nai Brith Canada records provide an encapsulated history of the social service organization's work and activities. Researchers will find files about the United Church-B'nai Brith dispute in this series. The League for Human Rights series contains files on its efforts to combat social discrimination in Canada. The Canada-Israel Committee series contains subject files relating to major issues dealt with by the Committee in the 1970's and 1980's. They include the Arab Boycott of Canadian companies and citizens trading with Israel; the proposed Canadian Embassy move to Jerusalem and the entry of Palestine Liberation Organization members to Canada to attend U.N. sponsored conferences. Most of the files in this collection were sorted and arranged at the National Archives. Subject files were created where necessary. This finding aid contains a file list and index.
