PIGEON, Louis-Philippe (1905-1986). Juge.

Originaux, 1943-1980. 7.6 m. Instrument de recherche n° 1659.

Louis-Philippe Pigeon est né à Henryville (Québec) le 8 février 1905. Après ses études en droit à l'Université Laval, il est admis au Barreau de la province de Québec et pratique le droit comme membre de l'étude Saint-Laurent, Gagné, Devlin et Taschereau de 1928 à 1938, de l'étude Pigeon et Hudon de 1938 à 1940 et de l'étude Germain, Pigeon, Thibodeau et Lesage de 1940 à 1967.

En 1935, Louis-Philippe Pigeon est secrétaire du Jeune Barreau de Québec, il en devient président l'année suivante. En 1938, il entreprend une carrière de professeur à l'Université Laval. Il est successivement chargé du cours de Droit civil à l'École des Sciences Sociales en 1938, professeur agrégé de la Faculté de Droit en 1943 et professeur titulaire de Droit Constitutionnel de 1943 à 1967. De 1940 à 1944, il assume la fonction de Secrétaire légiste de la législature du Québec. En 1947-1948, il est président de la Société des Études Juridiques de Québec. De 1960 à 1966, le Premier ministre du Québec, Jean Lesage le nomme son conseiller juridique. Louis-Philippe Pigeon est également président du Conseil national pour l'administration de la justice de 1963 à 1967, vice-président de l'Association canadienne du Barreau en 1965-1966, vice-président de la Conférence des commissaires pour l'uniformité des lois en 1966-1967 et président du Conseil national d'éthique professionnelle en 1966-1967.

Louis-Philippe Pigeon quitte ces nombreuses fonctions lorsqu'il est nommé juge de la Cour suprême du Canada le 21 septembre 1967. Durant sa carrière de juge, il travaille entre autre à promouvoir le bilinguisme à la Cour suprême. En janvier 1971, il représente le Canada à la Conférence des juges du Commonwealth tenue à New Delhi. Il prend sa retraite le 7 février 1980.

Louis-Philippe Pigeon est l'auteur de nombreux écrits et ouvrages du domaine légal dont le plus renommé est son travail intitulé Rédaction et interprétation des lois. Il a été reçu Compagnon de l'Ordre du Canada et les universités Laval, Bishop et Ottawa lui ont décerné des doctorats honorifiques. Il avait épousé Madeleine Gaudry le 29 août 1936. De cette union sont nés six enfants. Il est décédé le 23 février 1980 à Ottawa.

Le fonds Pigeon a été présenté aux Archives par l'Honorable Louis-Philippe Pigeon en 1980.

Les imprimés et les photographies ont été transférés aux Divisions appropriées.
