## INTRODUCTION

The Gordon Ritchie fonds consists of 17 boxes of documents (3.300 m., 1976-1988) arranged in series and sub-series based on the major activities of his career in the Canadian public service. Within the series and the sub-series, the files are generally organized in alphabetical order. However, continuous series of the same type of documents were kept together in their original chronological arrangement (ie. chronological files, assessment notes).

Complementary documents to the fonds may be found in the official records of the Department of Industry, Trade and Commerce (RG 20), the Department of Regional Economic Expansion (RG 124) and the Trade Negotiations Office of the Department of External Affairs (RG 144) which are kept at the Government Archives Division of the National Archives of Canada.
