INTRODUCTION

The Albert Edgar Ritchie papers document the activities of a senior civil servant which held important positions in the conduct of Canadian foreign affairs in the 1960's and 1970's: Assistant and Deputy Under-Secretary of State for External Affairs, Ambassador to the US and Under-Secretary of State for External Affairs. They also include valuable files of Hume W. Wrong and Norman A. Robertson, men who were instrumental in the elaboration of a Canadian foreign policy in the 1940's, 1950's and 1960's.
