Introduction

The Finding Aid (FA) for the James Reid papers, MG 24 B173, reflects two bodies of information. Part 1 pertains to the James Reid documents in the National Archives of Canada, Manuscript Division. Part 2 pertains to the James Reid documents which are in the custody of the Bar of Montreal; these documents were loaned to the National Archives for microfilming.

The term "volume" was assigned to the documents based on how they were organized physically; that is, a bound book was considered a volume as was a customized box containing loose notes.

The FA indicates, whenever the information is available, the volume number within a series; the outside dates, the date of the court term; the location of the court; page numbers, when applicable; the name of the court; and any comments that were on the document such as "Term Incomplete".
