INTRODUCTION

This finding aid was re-written in January of 1994. The information that it contains is basically the same as that in the earlier 1970 version. But, some of the folder titles have been changed to better reflect their contents and a new series, "Additions", was added to describe acquisitions received after that date.

BIOGRAPHICAL SKETCH

The Federation of Canadian Artists was formed as the result of a conference held at Queen's University, Kingston in June, 1941. The conference was organized by André Biéler with the assistance of a grant from the Carnegie Corporation of New York, and the support of Queen's University. A continuing committee was established which recommended the formation of a Federation of Canadian Artists which grew into a nation wide organization. André Biéler was the first president. An article by Donald Buchanan in Saturday Night, 56 (August 2, 1941) gives additional information on the Conference.

The Federation was not a society of artists alone, but was made up of professional artists, amateurs and interested laymen. Its principal objective was to unite Canadian to further the function of art and to make creative life an inseparable part of the community.

To further these general aims the Federation supported a petition to the Prime Minister in 1942 asking that the work of artists be an integral part of the war effort. The Federation was also largely responsible for briefs being submitted to the Special Committee for Reconstruction and Re-establishment in 1944. What the FCA wanted as memorials of the war were community centres which would serve the cultural needs of communities. These were to be established not only in the big cities but in smaller sized cities across the land.

The membership of the Federation was organized on a regional basis, each province or branch had its regional executive with its chairman a member of the National Council. The National Council was the authority in matters of policy and finance.

Lawren Harris was the second president of the Federation. H.G. Kettle was for some time the Executive Secretary. Elizabeth Wyn Wood the sculptor, was deeply involved in the briefs concerning community centres.

Other people connected with the Federation were Walter Abell, John Coulter, Betty Hahn, Harry McCurry, at one time director of the National Gallery of Canada, Harry Mayerovitch, Harry Southam, W.L. Sommerville, Herman Voaden, Arthur Lismer, A.Y. Jackson, Frances Loring, Fred Haines, at one time president of the Academy, and Elizabeth Harrison of Kingston.
