## **DESCRIPTION OF THE FONDS (accrual files)**

### **Biographical sketch**

Harry Sutherland was born and educated in Toronto, Ontario, where he now practices corporate law. He is now retired. Sutherland began collecting stamps at the age of five, with his main collecting interests including; Local Issues of Chinese Treaty Posts (Shanghai and German Naval), Mail of WWI, Yugoslavia, and Montenegro. He has attended and exhibited at many international exhibitions and has received numerous high awards for his collections. Sutherland joined the Royal Philatelic Society of Canada (RPSC) in 1950, became director in 1957 and has served the Society as President (1967-1979), Secretary of the Board of Directors, Chairman of the Arbitration Committee, and Director of International Affairs. He has been director of the Fédération Internationale de Philatélie (FIP), (1976-1981), and remains as the chief Canadian delegate. In 1974 Harry Sutherland became Vice-President of the Federación Interamericana de Filatelia (FIAF) and then President in 1975. Sutherland is involved in numerous philatelic organizations; Fellow of the RPSC, and the Royal Philatelic Society of London, member of the British North America Philatelic Society (BNAPS), as well as member of the Philatelic Specialists Society of Canada. Mr. Sutherland is an international judge for philatelic exhibitions. He also served the Vincent G. Greene Philatelic Research Foundation by way of supervising the publication of books and the creation of the library. In 1991 he was invited to sign the Roll of Distinguished Philatelists, and the year before received the FIAF medal for meritorious service to philately. Finally in 2002, he received the Alfred Lichtenstein award from the Collectors Club of New York.

### **Scope and content of the accrual files**

Records consist primarily of textual records relating to the Royal Philatelic Society of Canada [1990-2003] (Annual meetings, Directors meeting, Exhibitions, Jury accreditation, Group Insurance, Fédération internationale de philatélie), Philatelic Congress of Great Britain [2000-2002], Federación Interamericana de Filatelia [1999-2002], International Philatelic Exhibitions [2001-2003] (Tokyo, Hafnia, Belgica, Armenia, Indonesia, Spain, PhilaKorea), Fédération internationale de philatélie [2000-2002], Philatelic Organizations such as BNAPEX [2001-2003]. Other files are also represented: Lichtenstein Award, Roll of Distinguished Philatelists, Toronto Association of Philatelic Exhibitions (Tape) [2000-2003].

Also included 17 Government First Flight covers for the year 1939. The two flights involved are The Trans-Atlantic Service Pan American Airways - Dispathes (27 June - 1 July: 6 postal covers) and the Imperial Airways Trans-Atlantic Service (5-10 August: 11 postal covers).

### **Immediate source of acquisition**

Records were acquired from Harry Sutherland by gifts to Library and Archives Canada from September 1, 2001 and October 23, 2003.

**Description of the finding aid**

Files in this finding aid come from accessions 2003-0726 and 2001-0682. They are arranged as previous accessions described in the fonds. The series include: Royal Philatelic Society of Canada (and sub-series), Federación Interamericana de Filatelia, Fédération Internationale de Philatélie, and the Personal collection.

**Access restriction**

All textual records and photographs (volume 4 to 7) are closed until October 10, 2018. Philatelic records (volume 8) is open. No restriction.
