INTRODUCTION

ii

Sir Archibald Campbell (1769-1843) was a career soldier in the British Army who served in India and Portugal before becoming Lieutenant-Governor of New Brunswick, 1831-1837.

The papers are composed of duplicate copies of official communications written to Sir Archibald Campbell while he was Lieutenant-Governor of New Brunswick. They are also available on microfilm (reel C-2074).

Finding Aid No. 699 consists of a descriptive list of the papers, which are arranged in a rough chronological order.
