JARVIS, Edward James (1788-1852). Judge.

Edward James Jarvis (1788-1852), a native of New Brunswick, studied law in England and was admitted to the bar of New Brunswick shortly before being named to the Supreme Court of that province in 1822. When his appointment was not confirmed, he obtained the post of Assessor to the Government of Malta, and on the elimination of that position by a reorganization of the government in 1827, he was named Chief Justice of Prince Edward Island, a position he held until his death. His first wife was Anna Maria Boyd (1787-1841), whose sister Mary Caroline (1798-1867) married his brother William Jarvis (1787-1856).

Finding Aid No. 701 provides a descriptive list of the papers in chronological order, integrating the two portions of the collection, and an author list for the correspondence on microfilm.

Correspondence, petitions, memoranda, legal documents and other records of E.J. Jarvis, 1783-1852 (12 cm). Included are letters received, documents relative to his appointment to the Supreme Court of New Brunswick, and the quit-rent question in Prince Edward Island, land disputes and the Chief Justiceship of P.E.I., and to the administration of New Brunswick, c.1823. Presented in 1939 by Col. Meredith of Ottawa.

Correspondence, legal financial and estate papers, newspapers and related records accumulated by E.J. Jarvis and the executor of his estate, 1747-1857 (28 cm). Included are documents relative to his career in New Brunswick, Malta and Prince Edward Island. Presented in 1976 by Michael Jarvis of Ottawa. Related records of his son Henry Frederick Jarvis are to be found in MG 24 K 57.

"Chronicles of the Jarvis Family", 1786-1901, composed of correspondence exchanged by William Jarvis (1787-1856) and his wife Mary Caroline Boyd (1798-1867), Edward James Jarvis and his wife Anna Maria Boyd (1787-1841), and William's son William Munson Jarvis (1838-1921), as well as other family members. The letters reflect family interests, family ties, and the social, political and economic circumstances of the times (Microfilm, reel M-1963). Copied in 1979 from the typescript loaned by Mrs. R.S. Fitzrandolph of Fredericton, N.B. The originals are now in the New Brunswick Museum. The correspondence was used as a basis for Arabella's Letters, together with the Contents of her small Diary, 1823-1828 by Arabella M. Stuart (Toronto: Musson Co., 1927 ?), which Mary Caroline Boyd wrote under that pen name.

THE JARVIS FAMILY

Edward James Jarvis (1788-1852), the second son of Munson Jarvis (1742-1825), studied law in England before returning to New Brunswick to be admitted to the bar. His nomination to the bench of the Supreme Court of New Brunswick by Lieutenant Governor G. S. Smyth in 1822 was not confirmed following Smyth's sudden death. E. J. Jarvis supported Christopher Billop against Ward Chipman in the dispute over the office of Administrator of New Brunswick in 1823. Efforts to have his appointment confirmed were partially successful: E. J. Jarvis was offered the post of Assessor to the Government of Malta, which position he held until a reorganization of the administration in 1828 eliminated it. In compensation he was offered the position of Chief Justice of Prince Edward Island, which office he held until his death.

The various disputes in which Jarvis was involved and the difficulties he encountered in obtaining and maintaining official employment are reflected in his papers. Related papers of his son Henry Fitzgerald Jarvis (see MG 24, K 57) also throw light on the question of patronage in the nineteenth century. A strong relationship between collections is found with the papers of E.J. Jarvis and his son H.F. Jarvis as well as his grandson Ernest Frederick Jarvis (MG 30, E 82).

E. J. Jarvis married Anna Maria Boyd (1787-1841) and they had several children. He remarried some years after her death. His brother William Jarvis (1788-1856) quite late in life married Mary Caroline Boyd (1798-1867), sister of Anna Maria Boyd, and they had one son, William Munson Jarvis (1838-1921). The "Chronicles of the Jarvis Family" are composed of correspondence exchanged by these closely-related individuals and other family members. The letters reflect the lives and interests of the family, strength of family ties, and the circumstances of the times. Mary Caroline Boyd published, under the pen name Arabella M. Stuart, Arabella's Letters, together with the Contents of her small Diary, 1823-1828, based on correspondence from the years of their sojourn in Malta (when she accompanied her sister Anna Maria).



### Origin and Arrangement of the Collection

The original material was received in two portions, the first (pages 1-644) in 1939 from Col. C. P. Meredith of Ottawa and the second (pages 645-2113) in 1976 from Michael Jarvis of Ottawa. The first lot was arranged in a series of correspondence, alphabetically by author; petitions and records of efforts to obtain public office; records of the dispute over the administration of New Brunswick, 1822-1823; records of the administration of Prince Edward Island, and miscellaneous papers, each in approximately chronological order. The second lot was arranged chronologically within three major subdivisions: correspondence, accounts and legal records, and newspapers and miscellaneous records. For ease of access, this finding aid attempts to list all the records in strict chronological order. Undated material which can be given an approximate date is described where it appears to belong; if not, it is listed at the end.

A number of maps received with the collection in 1976 but not apparently related to it were transferred to the National Map Collection. Photographs of a pair of silhouette portraits of Chief Justice E. J. Jarvis and his wife were also received in 1976, from E. A. Meredith Jarvis of Ottawa, and transferred to the National Photography Collection.

The "Chronicles of the Jarvis Family" were microfilmed in 1979 from the typescript loaned by Mrs. R. S. Fitzrandolph of Fredericton, N.B. The original correspondence is in the New Brunswick Museum at Saint John, N.B. The letters follow a strict chronological arrangement and are provided with tables of contents for the six "volumes". This finding aid also provides an author list. It should be noted that some genealogical tables are included with the "Chronicles."
