Introduction

Introductory Note

The Carleton County Poll Books and Registers of Voters (Volumes 2-6) were paginated when first acquired. In 1980 the volumes were reboxed and the listings revised. Pages 6 to 15 provide a list of the material, page references and the volume number. Material is listed alphabetically by township in this list only, as an aid to locating documents. Arrangement within each volume is chronological.

Volume I contains a variety of small items: Petition of the inhabitants of Carleton County for representation in the House of Assembly of Upper Canadan, 1 June 1819; Warrant appointing Roderick Matheson County Returning Officer, 12 June 1820, return of the election of William Morris, 11 July 1820; and poll book of the election held at Perth, 10 July 1820 (pages 1-54). Presented in 1920 by Captain A.F. Matheson of Perth Ontario.
