SCOTT, Richard William (1825-1913). Minister and Senator.

Originals, 1812, 1843-1913. 4.25 m. F.A. No. 143.

Hon. Sir Richard William Scott (1825-1913), lawyer, was a Conservative Member of the Legislative Assembly of Canada, 1857-1863, and the Legislative Assembly of Ontario, 1867-1873, (Speaker, 1871). He became a Liberal in 1873 as Commissioner of Crown Lands in the Blake Cabinet, 1871-1873, and was a Member of the Senate, 1874-1913, (Minister without portfolio, 1873-1874, Secretary of State, 1874-1878, 1896-1908, and government leader, 1902-1908).

The Scott Papers were presented by his son, W.L. Scott, in 1928 and 1931. Most of them are related to the separate schools question in Ontario, Manitoba and the Northwest Territories. There are no papers concerning the Canada Temperance (Scott) Act and very little concerning the activities of Scott as Secretary of State.

The finding aid No. 143 is an alphabetical list of correspondents, giving dates, subjects and page numbers.
