Memoranda of a journey from London to Cork where McGillivray found that  
he was too late for the Quebec packet. He then decided to return to  
England so that he could sail from Falmouth to Halifax. Two pages of  
pencil calculations in reverse of the book (16 pages).

II Voyage to Canada, 1814.

Calculations on insurance of cargo (pp. 1-12); continued in reverse of  
book (pp. 50-84); pencil diary of voyage via Halifax and then up the  
St. John River, 24 July-19 September, 1814 (pp. 13-49), and 20 September-  
26 September, 1814 (pp. 85-109).

III Memoranda, Montreal, 4 October-5 November, 1814.

Deals with the settlement between the Hallowell firm and that of McGillivray-McTavish. The two last pages contain accounts as of November, 1813 (47 pages).
