## INTRODUCTION

Finding Aid 169 provides a very brief listing of the papers accumulated by George Hamilton, 1803-1838, and his family, 1840-1888 and 1906. The papers include correspondence and other documents of George Hamilton (1781-1839) and his family, most notably his brothers William, Robert and John. Many relate to the lumber mills at Hawkesbury which were owned and operated by the Hamilton brothers until 1888, when the business was sold to the Hawkesbury Lumber Company. Other subjects include the militia, the Rebellion of 1837-1838 and family matters.

Unless otherwise noted, the items described are letters.
