### INTRODUCTION

The papers of Sir John Coape Sherbrooke are composed of microfilm (volumes 1-17 and 22) and originals (volumes 18-21). This finding aid contains a descriptive list of the contents of volume 18-20 and - a microfilm shelf list.

MG 24 SHERBROOKE, Sir John Coape (1764-1830). Soldier and states-

Originals, 1811-1818, 20 cm. Microfilm, 1808-1830, reels A-887 and A-888. Finding aid no. 179.

Sir John Coape Sherbrooke (1764-1830) served with the British Army, 1780-1811 until he was appointed Lieutenant-Governor of Nova Scotia. In 1816 he took up the post of Governor-in-Chief of the Canadas, resigning after two years' service. His later years were spent in retirement.

Volumes 1-17 were microfilmed in 1968 from originals in the possession of Rear-Admiral R. St. Vincent Sherbrooke of Oxton, England. Volumes 18-21 were presented in 1970 and 1 1971 by a member of the family, and volume 22 was microfilmed in 1973 from the original in the possession of another member of the family. (Reel A-888 was formerly M-1034)

Finding Aid No. 179 provides a descriptive list of the contents of volumes 18-20.

They are arranged in series of journals of Sir John, 1809-1818 (volumes 1-5; reel A-888) and his wife Lady Katherine Pyndar Sherbrooke, 1811-1818 (volumes 6-13; reel A-888); correspondence, 1813-1830, troop returns, military records, addresses and replies, 1814-1818, and accounts, 1809-1819 (volumes 14-17; reel A-888); further correspondence, 1811-1818 (volumes 18-19; 15 cml), an "out-letter book", 1813-1814 (volume 22; reel A-887) and letterbook of correspondence for the Commanders-of the Forces 1815-1816 and a resgister of Lord Bathurst's despatches (volumes 20-21; 5 cm.). A farewell address to Sir John, 1818, is in the Horizontal filing cabinet.
