John White served as Attorney General of Upper Canada from December 1791 until his death following a duel with John Small; Clerk of the Executive Council, in January 1800. He also sat as member of the Legislative Assembly for Leeds, 1792-1796. His brother-in-law, Sir Samuel Shepherd (1760-1840), was an outstanding member of the British legal profession and Chief Baron of the Scottish Exchequer, 1819-1830. He was instrumental in obtaining White's appointment in 1791 and undertook the upbringing of his children following his death. Charles Samuel White (1790-1823) was prepared for a career in the Royal Navy; William Glendower White went into the service of the East India Company, retiring in England as a Lieutenant-Colonel.

John White's diary was copied in 1915 from originals then held by Miss Helen Merrill of Toronto, and now with the Metropolitan Toronto Reference Library. The correspondence, legal and business papers were received in 1958 from Mr. Edmund Parkin of London, England. The additional material was received in 1991 from the British Records Association, London, England.

No Restriction on Access.

Finding Aid No. 207 is an item-by-item list of the diary, correspondence, legal and additional papers, with a file description of the business material.

#### INTRODUCTION

John White (d. 1800) served as first Attorney General of Upper Canada, 1791-1800, and as Member of the Legislative Assembly for Leeds, 1792-1796. He died following a duel with John Small, Clerk of the Executive Council, 3 January 1800.

Sir Samuel Shepherd (1760-1840), an outstanding member of the British legal profession, was instrumental in obtaining the post of Attorney General for his brotherin-law, John White. He later assumed responsibility for the education of White's children and general administration of the estate. Charles White was prepared for the Navy and William White was given a military education and entered the East India Company Service.

#### Volume 1

The diary of John White contains entries describing the trip to York in the suite of William Dummer Powell, the ceremonies marking the inauguration of civil government in Upper Canada, his election to the first Legislative Assembly in 1792 and events of his life at York and Kingston between June 1792 and April 1794. Interspersed throughout are notations of his financial affairs and a systematic summary of accounts for 1792-1797 appears on pages 76-95.

#### Volumes: 2-4

The correspondence and other papers of John White and Sir Samuel Shepherd are arranged in groups: letters of John White to Shepherd regarding his professional and personal life, 1792-1799, copies of letters by John White regarding applications for offices, 1798-1799, letters regarding White's death and settlement of his affairs, 1800-1813, business papers, 1780-1804, accounts, 1786-1809, and the will of Sir Samuel Shepherd, 1840.
