HARVEY, Horace

Horace Harvey was born in Elgin County, Ontario in 1863, the son of William Harvey, Liberal Member of Parliament (1872-1874) for Elgin East. He was educated at the University of Toronto and graduated with the degrees of Bachelor of Arts in 1886 and Bachelor of Laws in 1888. He was called to the Ontario bar in 1889 and practiced in Toronto. In 1893 Harvey moved to western Canada where he was called to the Bar of the North West Territories and practiced in Calgary. He was successively appointed registrar of land titles for Southern Alberta in 1896, deputy attorney general of the North West Territories in 1900, puisne judge of the Territorial Supreme Court in 1904, puisne judge of the newly created Supreme Court of Alberta in 1907 and Chief Justice in 1910. On the reorganization of the Alberta Courts in 1921, Harvey became Chief Justice of the Trial Division. Three years later he became Chief Justice of the Apellate Division and he held this position until his death. He served as Chairman of the Board of Governors of the University of Alberta (1917-1940) and of the Mobilization Board for National Services (1940). He died at Edmonton in 1949.

Also includes several letters concerning his interest in stamp collecting. Arranged alphabetically by correspondent within each year.

Official Correspondence, 1904-1949. Originals, 70 cm (volumes 34-40). Correspondence between Harvey and the Supreme Court of Alberta relating to court cases, with the North West Mounted Police, regarding the treatment of prisoners and with the Attorney-General's Department and his colleagues on the Bench concerning sessions of the Court. Also includes correspondence between Harvey and the Minister of Justice regarding the exercise of executive clemency. Arranged alphabetically by correspondent within each year.

Memoranda and correspondence relating to Harvey's law firm in Calgary and its dealings with the Dominion Building and Loan Company, the Canada Permanent Loan and Savings Company and various Court cases. Arranged alphabetically and chronologically within two subseries.

#### PERSONAL CORRESPONDENCE

This correspondence is arranged alphabetically by correspondent within each year. There is routine correspondence between Harvey and the Attorney-General's Department as well as correspondence with his colleagues on the Bench relating to cases before the courts, judgments rendered and schedules of sittings. There is also a small number of letters either sent to or received from political figures dealing with matters such as the formation of the provinces of Alberta and Saskatchewan in 1905 and appointments to the Bench. The papers also contain a good deal of personal correspondence relating to the University of Alberta, where Harvey served as Chairman of the Board of Governors, to his private business interests in real estate and to his interest in stamp collecting.

#### OFFICIAL CORRESPONDENCE

This correspondence is arranged alphabetically by correspondent within each year and covers the period of Harvey's judicial career. There is routine correspondence between Harvey and the Supreme Court of Alberta pertaining to court cases and with the North West Mounted Police regarding prisoners held at various posts and the granting of bail. Considerable official correspondence dealing with court sessions was exchanged between Harvey and the Attorney-General's Department and with his colleagues on the Bench. Finally there is some correspondence between Harvey and the Minister of Justice regarding the exercise of executive clemency for persons under heavy sentence.
