INTRODUCTION

This finding aid provides listings of the papers accumulated by the British American Land Company, 1832-1935. The Inventory Entry and the shelf list provide general descriptions of the contents of each volume, as well as the microfilm reel number on which the volume will be found. This is followed by a detailed nominal list for the correspondence contained in volumes 2, 3, and 4.

The early transcripts in volume one of the collection were selected and prepared by R.W. Heneker, the Company's Commissioner for Canada 1855-1902, and were presented to the Public Archives in 1887. Prior to 1950, a Mr. Wells of Sherbrooke, Quebec presented further original records. To maintain existing references the early transcripts donated by R.W. Heneker have been retained as pages 1-18 of volume one.

MG 24 BRITISH AMERICAN LAND COMPANY (founded 1832)

Originals, 1830-1936. 58 cm. Finding Aid No. 242.

The British American Land Company was formed in 1832 to promote settlement and land development in the Eastern Townships of Lower Canada in a manner similar to that of the Canada Company in Upper Canada. In 1834 it received a Royal Charter which provided that certain Crown lands were to be conveyed to the Company in return for "valuable considerations". Initially the Company prospered and large numbers of settlers located on its lands. Heavy financial responsibilities and the political unrest resulting from the Rebellion of 1837 worked to the detriment of the Company however, and in 1841 it was forced to return over 500,000 acres of its original allotment to the Crown. The British American Land Company was supported and managed by several prominent individuals, including Sir Alexander Tilloch Galt who held the position of Commissioner from 1844-1855.

The majority of the collection was presented prior to 1950 by a Mr. Wells of Sherbrooke, Quebec.

Finding Aid No. 242 provides a nominal list of correspondence for Volumes 2, 3 and 4, and a descriptive shelf list for the remainder of the collection.

The collection was microfilmed in 1981 and has now been withdrawn from circulation. RESEARCHERS MUST USE THE MICROFILM, reels C-15685 to C-15687.

Official records, 1832-1895. Originals, 5 cm (volume 1, reel C-15685). Charter, by-laws, and other official documents 1832-1895, relating to the organization, policy and history of the Company, including a historical sketch by R.W. Heneker, the Company's Commissioner in Canada, 1855-1902. Transcribed copies of significant agreements and reports were presented by Mr. Heneker in 1887. To preserve existing references these transcripts have been retained as pages 1-18 of Volume 1.
