Merchant Michael Mahoney was a Canadian diplomat. During the latter part of the World War I, he served in Washington. In 1918 he was transferred to the Canadian War Mission and was its secretary from 1918 to 1921. He was the First Secretary of the Canadian Legation in Washington, 1927-1938 and became the Legation's Commercial Counsellor, 1938-1945. In 1945 he was transferred to Dublin as High Commissioner.

Transferred in 1971 from the Department of Trade and Commerce.

The Finding Aid No. 729 is a chronological descriptive list of the items in the unit.
