Correspondence, memoranda, and reports accumulated by the Commander in Chief of the Pacific Station and left at Esquimalt when the base was transferred to Canada in 1910.

The Pacific Station was created as a separate entity in 1837 and Valparaiso was named as its headquarters. From the year 1848 ships of the Pacific Squadron began to use Esquimalt harbour. During the Crimean War the first naval buildings were erected at Esquimalt in 1855 when Rear Admiral Bruce requested James Douglas, Governor of Vancouver Island, to provide a building to serve as a temporary hospital. Douglas prepared three buildings which, although not required for hospital accomodation, were soon utilized as a store and provision depot. In 1865 Esquimalt was made a permanent base by a British Order-in-Council and for all practical purposes the port soon came to be recognized as the headquarters of the Pacific Station.

The records of the Commander in Chief were arranged by geographical area until 1893, when Rear Admiral H.G. Stephenson assumed the command. Stephenson gave instructions that all records were to be filed chronologically in one general series. In 1896 Stephenson's successor made a partial reversion to the old system by setting up separate files for British Columbia, Esquimalt, and the Behring Sea but apparently continued the general series for other records. The three series which were re-established have thus a gap, 1893-1896, which may only be filled by reference to the general series.

In 1923 the Admiralty placed some of the records which had been left at Esquimalt on deposit in the Public Archives of Canada. An additional group from the same source was deposited in the British Columbia Archives in 1937.

Finding Aid No. 762 is divided into two parts. The first part consists of a shelf list of the contents, by volume, for the 39 volumes of original correspondence of the Pacific Station Records that were deposited in the Public Archives of Canada. Within some of these volumes there is a more detailed listing of the contents. Also, Manuscript Group 12, Admiralty 155, contains a subject index to the correspondence contained in volumes 1 through 22 inclusive. It is available on microfilm reel B-20.

Part II of the finding aid describes the contents of the records of the Admiralty Pacific Station which were deposited in the British Columbia Archives in 1937 and later copied by the Public Archives of Canada. The contents of theses records are arranged in subject or case files. Each of the volumes includes a list of the files bound in it. The finding aid is an edited version of these lists with the addition of certain information (notably page numbers).
