Sir James William Montgomery (1721-1803), Lord Chief Baron of the Scottish Exchequer, was the largest proprietor of land on the Island of Saint John (later Prince Edward Island). He employed a number of agents to manage the estates, including one of his sons.

The Scottish Record Office, Edinburgh, possesses letters from Sir James Montgomery to John Spottiswood, a barrister of the Middle Temple, London. The correspondence is concerned with business affairs, including the administration of the Prince Edward Island Estates. The following list provides a detailed description of the letters and other papers, which were microfilmed in 1972 (reel A-865).

In addition to the microfilm copy of correspondence of Sir James William Montgomery, there are two letters of Montgomery to Robert Gray, secretary to the Governor, concerning charges against Edmund Fanning and his councillors, 1792. Originals, 8 pages. Acquired in 1946.

There are also photostat copies of letters from Montgomery to Henry Dundas, 1791, concerning quit rents and enclosing a memorial and two warrants on the subject (26 pages), and 1792, concerning Edmund Fanning's case (3 pages); from Robert Gray to Montgomery, 1792, concerning the Privy Council hearings (6 pages); and from Montgomery to Edmund Fanning, 1798, concerning settlement and the management of estates, quit rents, the cod fishery, Loyalist immigration, and general policy, (31 pages); together with a comparative statement of the Colonial Estimates, 1793-1794 (4 pages).
