COLEBROOKE, Sir William MacBean George (1787-1870) Colonial governor.

Originals, 1841-1848, 274 pages. Finding Aid No. 123.

Sir William MacBean George Colebrooke (1787-1870), after extensive service in the Royal Artillery and as Lieutenant governor of the Bahamas, Governor of the Leeward Island and Antigua, became Lieutenant-Governor of New Brunswick, 1841-1848. Subsequent to his service in Canada, he was Governor of Barbados, 1848-1856.

These papers were formerly part of the Delancy-Robinson Collection, acquired in 1918.

Finding Aid No. 123 contains a description list of the papers which are arranged in chronological order.

Correspondence and other papers, 1841-1848, of Sir William MacBean George Colebrooke relating chiefly to the Maine-New Brunswick dispute but also including numerous documents on the case of Thomas Baillie, on education in New Brunswick, and routine matters.
