Robert Alexander MacKay was born in Victoria Co., Ontario. Prior to graduating from the University of Toronto and Princeton University, Dr. MacKay served in the ranks of the 43rd Battery, Canadian Field Artillery 1916-1919. After a distinguished teaching career at Upper Canada College in Toronto, Princeton, Cornell and Dalhousie Universities, MacKay joined the Department of External Affairs in 1943 as special assistant. He became Chief of the Defence Liaison Division in 1947, and was Assistant and then Associate Under Secretary of State for External Affairs, 1952-1955. He served as Canadian Permanent Representative to the United Nations, 1955-1958, and Canadian Ambassador to Norway and Minister to Iceland, 1958-1961. MacKay is the author of numerous studies relating to Canadian politics, economics and diplomacy.

Volumes 1-6 of MacKay's papers were transferred in 1970 from the Department of External Affairs. Volumes 7-9 were presented in 1976 and volume 10 was presented in 1979 by R.A. MacKay of Ottawa. One letter dated 1931 was transferred in 1981 from the Public Archives Library.
