The Sharples lumber firm was the oldest in the Quebec square timber trade. having been established in 1816 by William Sharples of Liverpool. Henry Sharples. his son. subsequently took over the Liverpool end of the business, in partnership with his brother Charles who resided at Quebec their cousin John Sharples. The Quebec operations were conducted under the name of "C. & J. Sharples" and in 1870, when John Sharples became head of the business, it became known as "John Sharples Sons & Co." John Sharples (1814-1876) was prominent not only in the Quebec lumber trade but also in political. church and civic affairs, and in other fields of business. He was appointed to the Legislative Council for Stadacona division in February, 1874; served as Mayor of Sillery; was first superintendent of cullers in 1843, president of the Harbour Commission and a director of the Union Bank. On his death in 1876 the business was taken over by his sons William (1841-1886) and John (1848-1913), becoming then Known as "W. & J. Sharples". John Sharples (Jr.) also was Mayor of Sillery and, as his father had done. represented Stadacona division in the Legislative Council, from May, 1893 until 1913. He was president of the Quebec Chronicle Printing Co. and a director of various utility, railway and banking institutions. In 1907 he was created Chevalier of the Order of St. Gregory by Pope Pius X. On the death of his brother William in 1886 he had become sole proprietor of the business, and in 1914, following his own death, the style "W. & J. Sharples Reg'd." was adopted. By this point in the history of the company controlling management by members of the

Sharples family had ceased; the son of Charles Sharples, Lt. Col. John Sharples (1875-1936) had joined the family firm in 1893 but left it in 1898 to pursue an army career. William Power (1849-1920) had long been in the service of the firm and in 1906 became a partner, later becoming president of W. & J. Sharples Limited. He represented Quebec West in Parliament as a Liberal from 1902 to 1908 and 1911 to 1917. His son, Hon. W. Gerard Power (1882-1940), had joined the Sharples firm in 1897 and in 1921 became president and managing director of W. & J. Sharples Limited. He continued in this capacity until 1929. He sat in the Legislative Council, also for Stadacona division, from 1923 to 1934.

The firm dealt extensively in square and waney white pine, also red pine, oak, elm, ash, birch, and in staves and deals. Lumber was purchased from various Eastern lumbermen, brought to the coves maintained at Sillery and Bridgewater, and in large part exported to a number of prominent lumber merchants in England and Scotland. Consequently the records deal to a great extent with the details of shipping and selling lumber by consignment in the U.K. market.

The first named clipping seems to have been preserved because of an article on the Douglas family, which mentions genealogical ties with the Stewart family. The second clipping also concerns the history of the Douglas family.

#### Notes

There is a possible connection between items 1-6 incl. relating to Stewart family history. Items 1-2 are letters addressed to J.D. Stewart. Item 3 refers to the fourth Earl of Aberdeen who was a Gordon; in 1805 he married Lady Catherine Hamilton; in 1815 he was remarried, to Harriet,

daughter of Hon. James Douglas, widow of James Viscount Hamilton; in 1818 he received royal license to append the surname Hamilton to Gordon. Item 4 possibly bears some connection with Aberdeen, who was Foreign Secretary at the time of the treaty. Item 5 contains clippings illustrating the connection between the Stewart and Douglas families. Item 6 also refers to the connections between the Stewart, Douglas and Hamilton families. However items 7-13 relate to settlement and sales of land in Canada, chiefly the Eastern Townships, and the connection between these items may lie in Prof. Lower's note and not with Stewart. (Papers referring to Sharples family were removed from this portfolio).
