#### INTRODUCTION

John William Woolsey (1767-1853), the son of an Irish immigrant of the same name, became one of the leading merchants and citizens of Quebec in the post-Conquest era. He served in the militia during the war of 1812, was the first president of the Quebec Bank, and was prominent in the movement in opposition to the Act of Union. He also improved the wharfage facilities and standardized the rates at Quebec.

These papers are derived from eight generations of the Woolsey family, including their related families of Lemoine (LeMoyne), Vanfelson, Honey, Keeling, Linegar and Pinhey, and also from various business enterprises and associates, including The Union Company of Quebec c. 1828-1850. The papers, in English and French and including carbons and photocopies, consist mainly of correspondence, certificates, deeds of sale and business records, wills and probate records, receipts and accounts as well as genealogical notes and charts. There are two journals of William Darley Woolsey, one in Latin from his theological studies at the Quebec Seminary, 1819 (120 pages) and the other in French entitled "Memoires du Tour en Ecosse, Angleterre, Irlande, France, Suisse et Italie, en 1822 et 1823." Also included in the correspondence is an early history of The Boy Scouts Association of Ottawa c. 1910-1911.

In addition, forty-seven photographs have been transferred to the National Photography Collection of the Public Archives as follows: two of views of Ottawa, one family group, and forty-four of members of the Woolsey family to 1972. (A photocopy of the photographed portrait of John William Woolsey and family, painted by Berczy in 1809, has been retained in the Systematic National Acquisition Program file. The original painting is held by The National Gallery.)

#### NOTES ON THE ORGANIZATION OF THE COLLECTION

Most of the files are focused on individual members of the Woolsey and related families. Thus they may be characterized as subject files, the subject being the person. The organization of the files into three volumes of records reflects the three separate deposits of materials, in 1960-1961, 1978 and 1985, and consists of: Volume 1, files 1 to 18, an itemlevel descriptive list of the papers of various Woolsey family members and business associates, arranged in chronological order; Volume 2, file 19, a descriptive list of genealogical notes and charts, and files 20 to 26, a file-title list of financial records; and Volume 3, files 27 to 33, a file-level descriptive list of the papers of various members of the Woolsey family.

Volume 1 and a portion of Volume 2 are paginated, which Volume 3 is unpaginated.

Finding Aid No. 360 provides descriptive lists of three volumes of records, reflecting three separate deposits of material: volume 1, files 1 to 18, an item-level descriptive list of the papers of various Woolsey family members and business associates, arranged in chronological order; volume 2, file 19, a descriptive list of genealogical notes and charts, and files 20 to 26, a file-title list of financial records; and volume 3, files 27 to 33, a file-level descriptive list of the papers of various members of the Woolsey family.

Journals, correspondence, baptismal and marriage certificates, wills and probate records, deeds of sale and business records, receipts and accounts, and genealogical notes and charts (including carbons and photocopies) 1767-1972, of four generations of the Woolsey family, commencing with Robert Woolsey, the uncle of John William Woolsey. Included in the papers are those of the Union Company of Quebec (1828-1850) and the Lemoine (Le Moyne), Vanfelson, Honey, Keeling and Pinhey families (30 cm; volumes 1-2). Files 1 to 9 were temporarily described in MG 55/24, No. 188. Presented in 1960-61 and 1978 by Edgar Garnet Woolsey of Ottawa.

Correspondence, certificates, wills and probate records, and genealogical notes and charts, 1910-1984, regarding eight generations of the Woolsey family (7 cm; vol. 3). Included in the papers, and forming files 27 to 33 of the collection, are references to the Pinhey, Linegar and Keeling families, and to the early history of The Boy Scouts Association of Ottawa. Presented in 1985 by Edgar Garnet Woolsey of Ottawa.
