André Taschereau was a justice of the Superior Court of Quebec. He was also a Professor of Corporation Law at Laval University. In 1943-1944 he was Bâtonnier-General of Quebec. In 1946-1947 he was President of the Governing Bodies of the Legal Profession in Canada. He became President of the Canadian Bar Association in 1952-1953.

Presented in 1973 by André Taschereau of Quebec City, Que.
