INTRODUCTION

In 1773, the Society of Jesus was abolished by Pope Clement XIV. On the death of the last former Jesuit in Canada, in 1800, the Jesuit Estates passed to the Crown. The Society of Jesus was reestablished in 1814 by Pope Pius VI and in 1842 its members returned to Canada. The question of the Jesuit estates was reopened and controversy continued until the Mercier administration indemnified the order in 1889.

The documents described here form only a small part of the records available for a study of the subject. Certain duplications may also be noted (see page 22 relative to the reports in RG 1, L 7 volumes 35-40A and in MG 11, Q series volume 50). The selection was made about 1956 at the request of a researcher and represent a certain interest in the subject.

The description provides the title and/or subject of the item, the MG or RG reference or Library reference (in the case of pamphlets) together with the microfilm reel number. The description is in the order in which the documents appear on the microfilm. The references 'Report, 1938, page..' are to the various calendars of Q Series, RG 7 G 1 and the Dalhousie papers which appeared in the PAC REPORT of the year specified. Little additional information is to be found there.

INTRODUCTION

En 1773, la compagnie de Jésus fut abolie par le pape Clément XIV et, après le décès du dernier Jésuite au Canada en 1800, leurs propriétés passèrent à la Couronne. En 1814, Pie VII rétablit cette société et, en 1842, les Jésuites revinrent au Canada. La question des biens des Jésuites fut alors soulevée mais ce n'est qu'en 1889 que le gouvernement Mercier les indemnisa.

Les documents décrits dans cet instrument de recherche ne constituent qu'une faible portion de l'ensemble des documents disponibles pour l'étude de la question des biens des Jésuites. De plus, au cours du copiage, on a microfilmé à plusieurs reprises une même version d'un document (voir la page 22 au sujet des rapports se trouvant dans RG 1 L7, volumes 35-40A, et dans MG 11, série Q, volume 50). Le choix de ces documents pour le microfilmage a été fait vers l'année 1956 à la demande d'un chercheur. Ce choix lui-même présente un certain intérêt pour l'étude de cette question.

La description contient le titre ou le sujet de la pièce, la cote MG ou RG ou encore la cote de la Bibliothèque des Archives publiques s'il s'agit d'une brochure, de même que le numéro de la bobine de microfilm. La description suit l'ordre dans lequel les documents ont été microfilmés. La mention "Report, 1938, page..." refère aux divers inventaires décrivant la série Q, RG 7 G l ou les papiers Dalhousie, inventaires publiés dans les <u>Rapports</u> des Archives publiques pour l'année indiquée. On ne peut trouver dans ces inventaires que peu de détails supplémentaires sur les documents. ii
