William D. Kearns was born and educated in Peterborough, Dntario. His trade union activities began in 1934 when he was instrumental in establishing the Beverage Dispensers Union. He was elected secretary-treasurer of Local 280 pf that Union and in 1954 was made a life member. In 1943 Kearns was elected an executive officer of the Toronto District Trades and Labor Council. Subsequently he served as the Council's Vice-President for three years and Secretary-Treasurer for four and one half years. Between 1951 and 1968 Kearns was the labour representative on the executive of the Community Chest of Greater Toronto and later on the executive of the United Community Fund.
