

SCOTT, WILLIAM LOUIS, 1872, 1891-1944. 7 feet, 8 inches.

W.L. Scott (1862-1947), lawyer and public servant, the son of Sir Richard and Mary (Heron) Scott, was educated at the Universities of Ottawa and Toronto. Called to the bar in 1887, he became prominent in the practice of law in Ottawa and in the field of child welfare. Besides being draughtsman and chief promoter of the Juvenile Delinquent Act of 1908 and president of the Ottawa Children's Aid Society and the Ontario Association of Children's Aid Societies, he was concerned with the legal aspects of child welfare legislation in other provinces and the questions of wife desertion legislation, separate schools sharing in corporation taxes, and various civic enterprises such as the Ottawa Symphony Orchestra. The papers were presented to the Public Archives by Mr. Scott at various intervals between 1938 and 1946.
