J.G. Currie (1827-1901) was born in York, Upper Canada. Having moved to St. Catherines and begun the practice of law, he entered politics and served successively as deputy-reeve of St. Catherines, warden of Lincoln County and mayor of St. Catherines. Before Confederation he represented the Niagara district in the Upper House and in 1871 successfully contested the Provincial riding of Welland County. On the first formation of the Mowat government, the " war horse of the Liberal party " was selected Speaker of the Legislature. He was named registrar of Lincoln County in 1881.

· · · · ·

Prominent in the militia, Currie attained the rank of Lieutenant Colonel and played a prominent part in repulsing the Fenian raid of 1866.

The papers consist chiefly of correspondence and newspaper clippings, supplemented by assorted notes, pamphlets, and political leaflets, arranged by subject.

E.A. Currie (1829-1913), née Harvey, was born in Niagara. In 1865 she married the Hon. James George Currie and, during his incumbency as Registrar of Lincoln County, was appointed Deputy Registrar. This position she held for several years. She was a supporter of the W.C.T.U., and advocate of women's suffrage and one of the founders of the Protestant Orphans' Home of St. Catherines. Her biography of Laura Secord was published first in 1900 and again in 1913, immediately after Mrs. Currie's death.
