PREFACE

Part III of this finding aid provides a description of the Duckworth material (Reel M-3727) acquired in 1977 and 1978 from the Joseph Regenstein Library of the University of Chicago. The University acquired this material in two parts: about 1927, part of the collection was received, with other papers, as a donation from Frank Webster Jay, a prominent Chicago physician and surgeon, while the rest of the collection was purchased, in 1960, from Goodspeed's Bookshop in Boston. The two parts of the collection were integrated and arranged in 5 folders. The seven items purchased from Goodspeed are distinguished by the letter (G) in pencil in the lower right hand corner of the documents, and by the same letter in the right hand column of the descriptive list which follows. There are no page numbers on the documents, but arbitrary page numbers have been assigned in this finding aid so that the extent and location of the items being described or referred to could be shown.

CONTENT

The material included in this collection, like that in Parts I and II, relates mainly to Duckworth's official functions as Governor and Commander-in-Chief of Newfoundland, 1810-1813. Most of the items pertain to the operation of the Newfoundland squadron, but there is some overlap with the civil administration of Newfoundland in the material pertaining to the supervision of the fisheries, the protection of convoys, and the duties of officers of the squadron in the capacity of surrogates for the island. The material in Duckworth's order book for 1810 (Folder 2, unnumbered pages 124-202) is particularly helpful in explaining related items in Parts I and II.

Apart from one loveletter dated 21 January 1808, (the only item of personal interest in the collection), all the material falls between the years 1810 and 1812, the period of Duckworth's effective governorship of Newfoundland. With the exception of Duckworth's order book for 1810, the great majority of the documents are for the year 1812.

Among the routine matters of business for the direction of the squadron, there are several items relating to Duckworth's efforts to make friendly contact with the Beothuk Indians, which are a helpful supplement to the material on the same subject found in Parts I and II. Also worth special mention is a poster publishing the conditions for the leasing of former ships' rooms (unnumbered page 123, cf Part I, PANL page 1691).

ARRANGEMENT AND NOTES

The arrangement of the material on the reel is as follows:

FOLDER 1

Administrative Orders and Instructions, n.d., 1810 pp. 1-30

This first folder contains a number of copies of general orders and instructions, undated for the most part, addressed by Duckworth to the respective Captains and Commanders of the Newfoundland squadron. Similar items may be found in Part I, and others of a slightly different character in Part II.

FOLDER 3

Correspondence from the Ships of the Newfoundland Squadron, 1811-1812.pp. 31-93

Apart from three items for 1811, all the material in this folder is for 1812. It consists of official communications from the officers of the Newfoundland squadron and is similar to material found in Part II, DUC/7, and to some items in Part I, Series F.

FOLDER 4

Operational Reports from the Ships of the Newfoundland Squadron, 1810-1812 pp. 94-119

With the exception of one item for 1810 and two for 1811, all the material in this folder is for 1812. IIt consists of official returns made on report forms to Duckworth by the ships of his squadron, and is arranged by type of report. There are also convoy lists and one report of survey. Similar material can be found, for the most part, in Part I, Series F and Part II, DUC/7.

FOLDER 5

Miscellaneous Documents, 1808, 1811 pp. 120-123

This folder contains only two items: a loveletter from Duckworth to Susannah Buller shortly before their marriage in 1808 (for similar items see Part I, Series B) and a poster setting out the conditions for the leasing of former ships' rooms (for another copy, see Part I, p. 1691)

FOLDER 2

Duckworth's Squadron Order Book, 1810 pp. 124-202

When the microfilm of this collection was received in 1977, it was found that the order book in this folder had been inadvertently omitted from the film. When the supplementary film was received in 1978, it was spliced on to the end of the reel and is described in this finding aid in that location. No other order book of this type is found elsewhere in the collection, but there is comparable material in the 1812 letterbook found in Part II, DUC/16, and it should also be read in conjunction with the Admiral's Journals in Part I, Series F, and with the incoming correspondence from the officers of the squadron in Parts I, II, and III. It is the most informative part of this collection.

RELATIONSHIP WITH PARTS I AND II

Because of the different modes of arrangement followed in the three separate parts of the material in the P.A.C.'s collection, the researcher is advised to make careful use of the Table of Contents for their correlation, and to use the indexes to the three parts in close combination. A number of cross references have also been supplied in the descriptions of the material and in the notes in the three parts of the finding aid. These should afford a considerable amount of assistance, but the reader is warned that they are by no means exhaustive.
