INTRODUCTION

Henry Fitzgerald Jarvis (d. 1898) was a son of Edward James Jarvis, sometime Chief Justice of Prince Edward Island. He attended the medical school at Edinburgh University, 1845-1848, with attendance at lectures and demonstrations in the various city hospitals. When his father failed to obtain him a medical posting with the British Army, he returned to Prince Edward Island and practiced there.

Some correspondence of H.F. Jarvis to his father, or concerning his father's estate (of which he was an executor) is to be found with E.J. Jarvis' papers (see MG 24, B 13; described in Finding Aid 701). Other related papers may be found with those of his son, Ernest Frederick Jarvis. (see MG 30, E 82)

This collection of H.F. Jarvis' papers comes from three separate sources: material transferred from MG 55/29, no. 74; papers received with a gift of E.J. Jarvis papers presented in 1976 by Michael Jarvis of Ottawa; and papers received with a gift of E.F. Jarvis papers, presented in 1976 by E.A. Meredith Jarvis of Ottawa.

Annotations of the following description of the papers indicate the origin of the various parts of the collection.
