MARTLAND, Ronald (b. 1907). Judge.

Originals, 1958-1982. 9.8 m. Finding Aid No. 1670.

Born on February 10, 1907 at Liverpool, England, Ronald Martland was educated at the University of Alberta (B.A., LL.D.) and as a Rhodes Scholar, Oxford University (M.A., B.C.L.).

Called to the Bar of Alberta in 1932, he practised law at Edmonton from 1932 to 1958. He was professor in the Faculty of Law, University of Alberta and University of Calgary and Bencher of the Law Society of Alberta from 1948 to 1958. He was Judge of the Supreme Court of Canada from 1958 to 1982.

Judge Martland was married in 1935 to Iris Bury and they had three children. He was appointed Chancellor Emeritus, Anglican Diocese of Ottawa.

Presented in 1982 by Ronald Martland of Ottawa, Ontario.

Finding Aid No. 1670 consists of a descriptive file lists arranged alphabetically.
