## INTRODUCTION

### BACKGROUND

For a general introduction to the Prime Minister's Office (PMO) during the first and second Trudeau ministries (1968-1979, 1980-84), see the background information provided in the introductions to the finding aids to series MG 26 O 7 and MG 26 O 10.

By 1970 the Prime Minister's Office had more than doubled in size to 85 people (the Pearson PMO had a staff of 40), over half of whom worked in the Correspondence Division, which was responsible for the ever-increasing volume of mail and memoranda received by the office. "When Pearson was Prime Minister, the Mail averaged 185 letters, cards and wires a day; when Trudeau took over, it jumped as high as 550 a day but then settled back slowly to an average of 275 in the early months of 1972. While most Prime Ministers were content with routine answers, Trudeau insisted on effective answers, and this required a sophisticated organization. Mail from Ministers, MPs, Provincial Premiers and other VIPs was directed from the Correspondence Section straight to Trudeau's desk. Other letters which were of particular interest went to Trudeau with a draft answer which he could accept and sign or reject in favour of his own reply. The routine mail was handled by the staff without reference to Trudeau." (**Paradox: Trudeau as Prime Minister**, Anthony Westell: Prentice Hall of Canada, Ltd. Scarborough, Ontario)

Within the PMO, the Correspondence Division was responsible for both coordinating the registration and processing of the Prime Minister's correspondence and for records-management activities. Prior to automation, the Correspondence Division used sophisticated and somewhat complicated codes to file the correspondence (see MG 26 O 7). Once automation was introduced these codes were abolished and replaced with seven digit accession numbers (see MG 26 O 9). The change over does not appear to have had any affect on the size of the Correspondence Division Staff.

The chief officer in the PMO Correspondence Division was the Correspondence Secretary. From 1968 to 1984 this position was occupied by seven different people (in some instances, dates are approximate):

Although the name of the division and the title of its director changed several times during the 1968-1984 period, its operational responsibilities remained more or less the same.

## ARRANGEMENT

### **Correspondence (vols 1-21, 46-47):**

This sub-series includes the different kinds of correspondence encountered in the Correspondence Division office:

**Chronological Files** - Originals of correspondence sent to the PMO. Arranged chronologically by seven-digit accession number.

**Congratulatory Messages** - Messages sent to the PMO following the 1979 campaign. Arranged chronologically by month.

**Departmental Replies** - Copies of departmental replies forwarded from the PMO. Arranged by department.

**Information Copies** - Copies of departmental replies forwarded from the PMO. Arranged chronologically from 1974 to 1979 and alphabetically from 1976 to 1979.

**Returns** - Letters returned to the PMO. Arranged alphabetically.

**Unregistered Correspondence** - Backlog material. Arranged alphabetically by subject.

### **Reference Material/Ouvrages de Consultation (vols. 21-29):**

This sub-series consists of briefing books and other memoranda that served as reference material for various PMO staff members. Included in this sub-series are copies of the standard letters, Bibles and Official Documents utilized by the Trudeau PMO, as well as information on the subject classification systems adopted for PMO correspondence. The "Bibles" which were a "series of loose leaf volumes organized by subject, were the basic source material for the letter-writers. This reference material included excerpts from Hansard, speeches and press releases; together with direct quotations of the Prime Minister". (**The Prime Minister's mailbag: W.P.Irvine and R.E.B. ### **Staff Files (vols. 29-33, 48):**

These files in most cases are the working files of the individuals who occupied a position or positions in the Correspondence Division. The following persons can be found in this sub-series:

### **Tone Analysis / Topical Issues Reports (vols. 34-45):**

The tone analysis reports are computer-generated analyse of the tone (from favourable through to hostile) of correspondence received by the PMO. Arranged chronologically.

The topical issues reports are computer-generated reports on the topical issues mentioned in correspondence received by the PMO. The issues are identified by numeric codes. The reports

are arranged chronologically.

As their titles suggest, these sub-series reflect the two aspects of the Division's mandate: correspondence processing and records management.

## **REMOVALS FOR TRANSFER OR DISPOSITION**

During the processing of the Correspondence Division Series, some photographs, documentary art, audio visual material, and cartographic material were removed for transfer to the appropriate divisions within the National Archives of Canada. In addition, some publications, memorabilia, and other non-historical items were removed for disposition. All removals were documented with removal sheets.

## **RESEARCH POTENTIAL**

"People who write to the Prime Minister are seen to be opinion leaders' who are interested and who are likely to talk to their friends. A good answer, therefore, will help build support, and its effect is likely to spread beyond the single individual involved. There is also a realization that a letter might find its way into the press, so embarrassments are to be avoided. Thus a prime, if not the most important, function of the correspondence operation is as a means for the Prime Minister to communicate with some members of the electorate. The Correspondence Division is an important communication link between the Prime Minister and his electorate. The PMO's Correspondence Division responded to those citizens seeking the Prime Minister's ear, whether to express criticism or to announce their own personal hopes and fears. (**The Prime Minister's mailbag: W.P.Irvine and R.E.B. Simeon - Canadian Public Administration/Administration Publique du Canada**).

The documents in this series will guide the researcher through the process taken by the Correspondence staff to ensure that adequate answers were supplied to correspondents. Researchers will gain insight as to how the PMO went about answering the volumes of correspondence received on a daily basis. Of particular interest will be the standard letters, the bibles, and the departmental replies. Staff files reflect the daily work of the Correspondence Division and future planning.
