Eugene A. Forsey was born in Newfoundland and educated at McGill and Oxford Universities. He lectured in McGill's Department of Economics from 1929 to 1941. While Director of Research for the Canadian Congress of Labour and the Canadian Labour Congress, he made a study of the labour movement in nineteenth century Canada. He is the author and co-author of several books and many articles on constitutional and social issues. Dr. Forsey was a member of the League for Social Reconstruction and the Co-operative Commonwealth Federation, for which he ran in three elections in the 1940s. In 1970 he was appointed to the Senate.
