MONTEITH, Jay Waldo (1903-1981). Politician and Cabinet Minister.

Originals, 1935-1981. 3.06 m. Finding Aid No. 1365.

J.W. Monteith was born in Stratford, Ontario on 24 June 1903. He received his education in Stratford and at the University of Toronto and returned to Stratford as a chartered accountant. In 1936 he married Mary B. Strudley. Monteith was an alderman and then Mayor of Stratford in 1944-1945. Following in the footsteps of his grandfather and father, he sought election in Perth riding in 1953. He was successful in this and in the next six elections, sitting until 1972. From 1957 to 1963 Monteith was Minister of National Health and Welfare in the Diefenbaker government. In the House of Commons, he was a member of the committee to choose a Canadian flag and on the Income Development Program Caucus Committee. Monteith retired from politics in 1972 and died on 19 December 1981.
