MG 24 D 102 LESLIE, James and family (1786-1873). Businessman, Politician.

Originals, 1776-1933. 40 cm. Finding Aid No. 1346.

James Leslie was born at Kair, Kincardine, Scotland on 4 September 1786. He received his education at Marischal College and the University of Aberdeen prior to emigrating to Canada in 1804. Eleven years later, Leslie married Julia, the daughter of Patrick Langan, seigneur of Bourchemin and Ramesay.

Leslie's business activities began in earnest in 1809 when he established James Leslie and Company - later Leslie, Starnes and Company - in Montreal; however, he was not limited to that specialized wholesale trade in foodstuffs. He contributed to the formation of the Bank of Montreal and was a director of that institution from 1817 to 1829. In addition, through his connection with the Langan family, he was seigneur of Bourchemin, Ramesay and Lake Matapédia. After 1824, Leslie divided his time between business and politics. He was an M.L.A. for Montreal East, 1824–1838, and Verchères, 1841–1848; President of the Executive Council, 1848, and Provincial Secretary, 1848–1851; a Legislative Councillor, 1848–1867; and a Senator, 1867–1873. During this time, much of the work entailed in running the seigneuries was done by his son, Patrick, who remained in Montreal and who maintained a regular correspondence with James on family and business matters. James Leslie died at Montreal, Quebec, on 6 December 1873.

LESLIE, James and family (1786-1873). Businessman and Politician.

Correspondence, n.d., 1776-1906. 15 cm (volumes 1 and 2; available on reels H-1301 and H-1302).

The Leslie correspondence reflects the diversified interests of the family; business, politics and personal matters are almost equally represented. The correspondence between James Leslie and his business associates contains information regarding commodity price fluctuations, land speculation and the general business climate in Canada, the United States and the United Kingdom, while Patrick Leslie's correspondence often centres on the acquisition and breeding of livestock and his successes and failures in renting or selling land and buildings.

The business correspondence also contains political elements. As M.L.A. and Provincial Secretary, Leslie was kept informed about such developments as the popular standing and prospects of municipal and provincial governments in Lower Canada and about the Annexation Movement of 1849. Of particular interest are two partially encoded letters from Sir Francis Hinks in Washington (6 and 8 January 1851) which appear to report on the state of the reciprocity negotiations.

Estate Papers, 1803-1868. 19 cm (volumes 2-4; available on reels H-1302 to H-1303). The deeds, agreements for sales or leases and tax records for the Leslie seigneuries and other properties provide information on the intricacies of landholding in nineteenth century Canada; the receipts and contracts serve to document the complex business connections between families and nations in the same period.

Government Records, n.d., 1843-1852. 4 cm (volume 4; available on reel H-1303). The petitions, reports and correspondence deal with land titles and divisions and property losses in the 1837-1838 rebellion.

Subject Files, n.d., 1827-1861. 2 cm (volume 4; available on reel H-1303).

The newspaper clippings, notes, memorabilia, court records and financial papers of Lady Maria Bowes suggest the wide variety of Leslie's interests and activities.
