HALE, John and Family

John Hale (1764-1838) was aide-de-camp and secretary to H.R.H. the Duke of Kent, 1793-1798, and Paymaster General of the Forces, 1799. He sat as a member of the Legislative Council of Lower Canada from 1808 and the Executive Council from 1820 to 1838. From 1829 until his death he was Receiver General of Lower Canada, having acted in that capacity from 1824. He also held office as Inspector General of Public Accounts from 1807 and Treasurer of the Jesuit Estates from 1800. He married a sister of William Pitt, Earl Amherst. His father, General John Hale, had fought with James Wolfe at Quebec in 1759. His son, Edward Hale (1801-1875) was a member of the Legislative Council of Canada, 1841-1847, and of Quebec, 1867-1875.

Finding Aid No. 1292 provides a descriptive listing of the documents in order of their appearance within the collection and of the contents of reel A-1085.

Correspondence and family papers, 1799-1882. (Originals, 36 pages; volume 1).

Correspondence, certificates and genealogical notes, 1799-1882. Presented in 1913 by W.A. Hale of Sherbrooke, Québec.

Commissions and estate papers, 1817-1907. (Originals, 112 pages; photocopy, 4 pages; volumes 2-3).

Commissions, deeds, wills and certain newspapers apparently retained for their legislative content, 1817-1883, with a letter of 1907. Presented in 1960 by Col. Shulldham H. Hill.

Deed of sale for the Seigneurie de Saint-Anne, 1820. Acquired in 1978.

Commission appointing John Hale as Receiver General of Lower Canada, 1837. Acquired in 1980.

Letter of John Hale, 1826. Photocopy presented in 1981 by Ian Kimmerly of Ottawa.

Family papers, 1739-1954. (Originals, 31 cm; photocopy, 2 pages; volumes 4-6).

Correspondence, certificates, notebooks, estate records, newspaper clippings and other family papers, 1739-1954. Acquired in 1978. The genealogical notebook was presented in 1985 through the National Army Museum, London, England.

The papers are arranged chronologically in three series: a general series (volumes 4-5), newspaper clippings (volume 6) and miscellaneous items (volume 6). As noted in the Finding Aid, certain items were transferred to other Divisions for safekeeping. Some items are stored in the vertical file cabinets.

Correspondence from John and Edward Hale to Lord Amherst, 1817-1826, discussing personal and family matters (reel A-1085). Microfilm acquired in 1979 from the India Office Library, London, England, where the originals are held.

Provenance and contents of the collection

The Hale family papers have been acquired from a variety of sources, chiefly descendants of John Hale, as noted in the Inventory Entry. The arrangement of the documents within the volumes reflects the order of acquisition (volume 1 in 1913, volume 2 in 1960, volume 3 from several sources over the years 1978-1981, and volumes 4-6 in 1978 and 1983).

Certain items acquired with the main lot in 1978 and 1983 were identified as the proper responsibility of other divisions and have been transferred (as indicated in the list which follows). A number of printed works were found to be duplicates of existing holdings or not of Canadian historical significance and were not retained.
