James Philip Ian Tyas was born at Huntersfield, England on 9 October 1923. He was educated at the University of Manchester, where he earned a B.Sc. Honours and a M. Sc., and in 1951, he was named Research Fellow of the Physics Department at the University of British Columbia.

Tyas entered the Canadian public service in 1954 when he became a Science Officer with the Defence Research Board (DRB) and he remained in that position until 1965 when he became a Science Advisor with the Department of Industry, Trade and Commerce. While with the latter department, Tyas chaired the Science Secretariat Study Group on Science and Technical Information in Canada; advised the Canadian International Development Agency on assessing its requirements for information services and the proposed International Development Research Centre; advised the Dominion Bureau of Statistics on the need for a study on information and data flow; and participated in other information related projects.

Tyas left the Department of Industry, Trade and Commerce in 1971 and returned to England, where he died in 1973.

The corespondence, articles, notes, reports and memoranda provide information on many facets of the Science Council of Canada Special Study No 8, Scientific and Technical Information in Canada, including the initial correspondence, resource material and part 1 of the published report. Also included are Tyas' notes and proposals regarding information projects for the Canadian International Development Agency (CIDA) and the Dominion Bureau of Statistics (DBS).

The material has been arranged chronologically by project and, where possible, Tyas' file titles were kept. The majority of the reference material was arraged topically by sub-group within the Science Council Study Group and with the aid of that job description in Tyas' curriculum vitae, however, because of the nature of Tyas' work with CIDA and DBS, and his interests, some of the materials post-date the termination of the study (1969). This material includes membership in, and correspondence with, committees of the Organization for Economic Cooperation and Development and the United Nations.

The Sound Archives holds a number of taped interviews and discussions on various themes connected with the Study Group (Acc. 1977-120).

65 slides and 3 films were transferred to Picture Division.
