INTRODUCTION

BIOGRAPHICAL INFORMATION

Isadore Levinter was born in Toronto in 1898. After graduating from Harbord Collegiate in 1915 he entered Osgoode Hall Law School, graduating in 1921. He entered private practice and soon established a reputation as a trial advocate and expert in compensation for expropriation of lands, negligence and insurance law. He was appointed K.C. in Jan. 1937.

Isadore Levinter was elected the first Jewish Bencher of the Law Society of Upper Canada in April 1956. An active participant in the affairs of the Society, he helped mould the original shape of Legal Aid in Ontario. He served on the Legal Aid Committee of the Society including a period as its chairman. He was a founder of The Advocates' Society, Toronto in 1965 and was made a Life Member in 1979.

Isadore Levinter was an active member of Beth Tzedec Congregation, Toronto for many years. He was on the first Board of Governors in 1952 and served as its president, 1969-1970. In the aftermath of Rabbi Stuart E. Rosenberg's dispute with Beth Tzedec in the early 1970's, he joined Shaarei Tefillah Congregation.

THE ARRANGEMENT OF THE COLLECTION

The personal papers of Isadore Levinter were transferred to the Public Archives in 1980 and 1981. Many of the files contain correspondence as well as notes, briefs and memoranda prepared by Isadore Levinter. This finding aid no. 1312 is a listing of the file titles within the four subject series. At the Public Archives researchers might wish to consult the records

of the Canadian Bar Association (MG 28 I 169). Photographs were transferred to the National Photography Collection and printed material to the Public Archives Library.

Personal Papers, 1918-1980. 50 cm., Vols. 1-2.

Personal documents and correspondence accumulated by Isadore Levinter primarily during the post-war period arranged chronologically. There are many personal letters from prominent figures within the legal community in Ontario including Edson Haines and Bora Laskin.

Community Affairs, 1944-1979. 38 cm., Vols. 2-4.

Correspondence, reports, receipts, clippings, speeches and minutes of meetings primarily related to involvement with Beth Tzedec Congregation, Toronto. Much of the material deals with his period as President as well as the conflict between Rabbi Stuart Rosenberg and several members of the Congregation's Board of Governors.

Legal Series, n.d., 1934-1979. 92 cm., Vols. 4-9.

Correspondence, clippings, notes, briefs, daily journals, memoranda and minutes of meetings which document Isadore Levinter's involvement with various legal associations and their committees, including the Law Society of Upper Canada, the Canadian Bar Association, Ontario Section, The Advocates' Society, Toronto and The International Academy of Trial Lawyers. There is material on the size of the Grand Jury in Ontario, legal aid, assessing damages in negligence cases and legal education, areas which reflect Isadore Levinter's interest in the law.

Legal Cases, 1939-1978. 1.3 m., Vols. 10-16.

A collection of some of Isadore Levinter's more important cases which were reported in the case law. They deal primarily with the a) valuation of properties which have been expropriated and b) the law of negligence.

They include: City of Toronto Expropriation, E.R. Hablize1 and Lambton Mills Nursery, 1956-1958 (vol. 10); Samuel, Son & Company Ltd. vs. Municipality of Metropolitan Toronto, June 1960 (vol. 10); City of Toronto Expropriation, South Side of Queen Street West, 1969-1975 (vol. 11-12); Aynsley vs. Toronto General Hospital, 1962-1971 (vol. 13); Spruce Falls Power and Paper Co. Ltd. vs. Kamyer Inc. and Horton Steel Company, 1967-1978 (vol. 14-15); vol. 16 contains photocopies of two scrapbooks of the Mickey and Alex MacDonald Murder Trial, 1939.
