

THE RIGHT HONOURABLE JOHN DIEFENBAKER PAPERS

SERIES I, LEGAL SERIES

The Right Honourable John George Diefenbaker received greatest recognition as Canada's thirteenth Prime Minister. However, prior to 1956 he had attained national prominence in another field of endeavour. The Legal Series of the Diefenbaker Papers presents a documentary portrait of Diefenbaker as a successful lawyer. The 2.6 metres of records in this series contain information tracing his thirty-six year career from his call to the Bar of Saskatchewan to his emergence as one of Canada's leading defense lawyers.

In his memoirs as well as in numerous speeches and interviews Diefenbaker recounted his childhood ambition to become a lawyer. He began his pursuit of this dream in 1912 when he enrolled in the Bachelor of Arts program at the University of Saskatchewan. He completed his degree and during the 1915-1916 academic year fulfilled the requirements for his Master of Arts degree. In 1916 Diefenbaker entered the University of Saskatchewan College of Law and shortly thereafter began a three year term as law clerk with Russell Hartney of Saskatoon. Diefenbaker interrupted his legal training by applying for active duty overseas in August 1916. His term in the army and subsequent convalescence were credited to his articling requirements. On April 1, 1918 Diefenbaker was able to resume his law clerk duties but later in the same year his services were transferred to the Saskatoon firm of Ferguson and MacDermid. A few months later, on September 1, 1918 his articles were once again re-assigned. Diefenbaker completed his articling duties with the firm of Lynd and Yule in 1919 and in May of that year he passed his final law examinations. His childhood ambition was finally realized in June 1919 when he was called to the Bar of Saskatchewan. (file: Law Office-Administration: Law Society of Saskatchewan-Assignment of Articles. 1918, Volume 26.)

Upon graduating Diefenbaker chose to open a private practice in Wakaw, Saskatchewan. He knew the region and Wakaw occupied a geographic position central to the three cities where high courts were held; Humboldt, Prince Albert and Saskatoon. The residents of the region had also developed a reputation for frequently engaging in litigation. Diefenbaker opened his office

in July 1919 and shortly afterwards hired Michael Stechishin, an articling student, to handle the solicitor work. He carried on a busy practice until 1924 when he moved to Prince Albert. The Wakaw office was managed by a succession of partners, R.B. Godfrey, Alex Ehman and Alex Philion, until its closure in 1929.

Diefenbaker joined a Prince Albert firm in 1925. The firm, Diefenbaker, Cousins and Godfrey was dissolved in 1927 soon after the death of F.C. Cousins. For several years Diefenbaker carried on a private practice but in 1929 he formed a partnership with William G. Elder. This arrangement lasted until 1932 when Diefenbaker once again resumed his private practice. In 1933 he hired an articling student named John Cuelenaere. It was the beginning of an association which lasted until 1956. In the early 1940s the firm of Diefenbaker and Cuelenaere was established. Roy Hall was added to the group in 1947 and Clyne Harradence became a partner in 1955.

When Diefenbaker came to Ottawa after his election to the House of Commons in 1940 he did not abandon his law career. Material received by the Prince Albert Office was forwarded to Ottawa when the House was in session and he would correspond with his clients throughout Prince Albert. This arrangement was continued until 1956 when he was elected leader of the Progressive Conservative Party. At this time Diefenbaker gave up his legal practice to devote full attention to the political arena.

During his distinguished career Diefenbaker received many honours and titles. He became a King's Counsel in 1929. He was a member of the Bars of Saskatchewan, Alberta, British Columbia and Upper Canada. He served as a Vice President of the Canadian Bar Association from 1939-1942 and in 1957 he received an Honourary Life Membership from the same organization. After his election as Prime Minister, Diefenbaker received many more honourary law degrees.

SERIES ORGANIZATION

In order to facilitate use of the Legal Series by researchers the material has been organized

into four subseries: Case files, Collections, Requests for Assistance and Administration files. Each subseries is arranged alphabetically by name of client, correspondent or subject. The contents of each file are arranged chronologically. This system has been imposed on the series since no discernable order existed in the papers prior to their organization. Material was drawn from a variety of locations but in some cases records relating to Diefenbaker's legal career have been left in other series. For example, notes written while he was in law school have been retained in the Pre-1940 Series together with his other academic notebooks. A file entitled "Legal Assistance Messrs. Diefenbaker, Cuelenaere and Hall cases" (file number 423.1) was left in the First Leader of Opposition Series since it contains material created after 1956 when Diefenbaker gave up his legal practice. Another file is located among the personal financial records of the 1940-1956 Series entitled, "Diefenbaker and Cuelenaere Law Firm-Expenses 1946". These files represent some of his law-related records which may be found in other locations.

Case Files include both reported and unreported cases of civil and criminal nature. The content of these files varies considerably but several types of records are predominant. They include routine correspondence with clients, handwritten notes by Diefenbaker, transcripts of trials and hearings, affidavits and relevant newspaper clippings. In many instances the information is sufficient to provide a full history of the litigation but there are many other files which are incomplete and do not present the final disposition of particular cases.

The Collection Files indicate the large amount of time Diefenbaker devoted to the collection of unpaid loans, sales, rent and other debts. This is also indicative of the economic difficulties experienced by westerners during the depression years. In many cases a tersely worded letter warning of possible legal action was sufficient to gain payment but on occasion a suit for reimbursement was launched. The cases which required extensive litigation have been placed in the Case file subseries.

The Request for Assistance Files contain correspondence between Diefenbaker and clients or prospective clients who sought legal advice on a wide range of matters. In many instances it is not known if legal proceedings resulted. A miscellaneous file (Miscellaneous Cases, Collections and Requests for Assistance, Volume 16) contains individual requests or replies which cannot be related to any other files. The Administrative subseries contains various files on the day-to-day operation of the law office. Such items as financial records, legal diaries, correspondence with stationery and office equipment suppliers are located here. Other files in the Administrative

subseries provide further insight into Diefenbaker's relations with his law partners, other lawyers, law societies and judges. Numerous other miscellaneous documents acquired by Diefenbaker over his lengthy legal career are located in this subseries.

RESEARCH USE

The Legal Series is a unique and invaluable source for researchers interested in Diefenbaker's law career. It is also a useful means of gaining insight into the types of activities undertaken by a small town, prairie lawyer during the 1920s and 1930s. While Diefenbaker's career cannot be described as typical, his records for this period do focus attention on the social and economic problems faced by western farmers and business people. His law career also serves to illustrate the skills he later used so successfully in the political arena.

In order to achieve maximum research benefits from the Legal Series researchers should endeavour to learn as much as possible about particular cases before the files are consulted. This will assist in the location of files which may be known by another name. For example Rex vs. Atherton, (Volume 7) is more popularly referred to as the Canoe River Case and Diefenbaker's first reported case, concerning the use of the French language in Saskatchewan schools, is properly titled Boutin et al vs. Mackie 1922 (Volume 1).

The series represents all of the known records relating to Diefenbaker's law career. His law office was twice damaged by fire and it is believed some records were lost on those occasions. The files in the Legal Series also reveal other business activities Diefenbaker conducted through his law office. There are references to his activities in the insurance and real estate fields. Some aspects of his political career, especially during 1955 and 1956, are also documented in the Legal Diaries. For example, information regarding appointments, speeches, trips and conferences are mentioned.

RESTRICTIONS

It is the intention of the Diefenbaker Centre and the Public Archives of Canada to provide

maximum access to the papers of the Right Honourable John G. Diefenbaker. The Legal Series, however, presents a unique problem regarding the question of restrictions. Any access to this series will be conditional on researchers' formal acknowledgement of responsibility with regard to publication of any information deemed an infringement of personal privacy so far as this relates to the sanctity of lawyer-client communications. Confidential information of this type found in the Case File subseries may not be quoted from directly and the identity of the client cannot be revealed. Requests for Assistance and Collection Files may be quoted from but the client's identity must not be published until ninety years have passed since the most recent date in the file. The Administration Files and all other types of information in the Series including court documents are free from restriction.
