Howard I. Ross was born in Montreal in 1907. He received a B.A. from McGill University in 1930 and an M.A. from Oxford University in England in 1932 as well as a number of honorary degrees. He was a partner with Touche Ross and Company, chartered accountants. Mr. Ross held numerous other posts including Chairman, Wartime Foreign Exchange Control Board 1940-43; Administrator for Rationing, Wartime Prices and Trade Board 1943-45; President of the Canadian Institute of Chartered Accountants; member of the Bladen Commission for the Financing of Higher Education and Chancellor of McGill University.

The files consist of correspondence, memoranda, addresses and clippings concerning the Carter Commission on taxation 1967-71, the campaign to abolish the excise tax on cheques 1952-53, the establishment of pensions for the self-employed 1954-47, ration administration in W.W. II 1944-45 and Trans-Canada Pipelines, 1968-72. There are also some biographical papers, 1962-1980, on H.I. Ross, assembled by I. Norman Smith.

The H.I. Ross papers also include a file on Arnold D.P. Heeney 1961-72 of correspondence and biographical clippings. A ledger of Philip Dansken Ross, publisher of the Ottawa Journal for the period 1903-34 concerning his investments and loans and several files of correspondence and addresses of P.D. Ross concerning honours and congratulations such as his induction into the Hockey Hall of Fame in 1976. (See also P.D. Ross Papers MG 30 D 98).
