SIFTON, Clifford (1893-1976) and Winfield Burrows (1890-1928).
Businessmen.

Clifford Sifton (1893-1976) was born in Brandon, Manitoba, the fourth of five sons of Sir Clifford W.B. Sifton. He was educated in Ottawa and Toronto and was called to the Ontario Bar in 1927. He served 1915-1919 in the Canadian Field Artillery, attaining the rank of Major and receiving the D.S.O. He acted as executive officer for the Sifton group of companies, and during the latter part of his life was primarily involved in the management of newspapers and radio and television stations. Following the purchase by the Siftons in 1928 of the Saskatoon Star-Phoenix and the Regina Leader-Post he became Vice-President of those two newspapers and Director of the Manitoba Free Press, and during the period 1935-1953 he was jointly involved with his brother Victor in the management of the three dailies. In a reorganization of the Sifton interests in 1953-1954 he became sole owner of the Star-Phoenix, the Leader-Post and the family's radio and television interests, severing his connection with the Free Press. In the last decades of his life he was Chairman of Armadale Corporation and of his two newspapers, Vice-Chairman of Quality Records Ltd., Chairman of Transcanada Communication Ltd. and President of Wentworth Radio-Broadcasting Ltd., and held a number of other positions.

Sifton was National Vice-Chairman of the Canadian Aid to Russia Fund, 1942-1944, held executive positions in the League of Nations Society in Canada, 1937-1940, the National War Finance Committee, 1940-1945, and other organizations, and was active in the Canadian Daily Press Association, the Canadian Association of Broadcaster and the International Press Institute.

Winfield Burrows Sifton (1890-1928), Sir Clifford Sifton's second son, graduated from the University of Toronto in 1910. During World War I he was A.D.C. to General Alderson, Commandant of the Val Cartier Camp, from 1914 until his discharge due to injuries in 1915. Thereafter he devoted himself to the promotion of various business projects, most of them short-lived, in London England and Montreal. He was called to the Ontario bar in 1928 and was a corporation lawyer for the Royal Securities Corporation in Toronto at the time of his death.

Correspondence reflecting the careers of Winfield and Clifford Sifton. The bulk of the early correspondence (1905-1935) is Winfield's, and concerns his business ventures and those of the Sifton family. The later correspondence, consisting primarily of copies of letters written by Clifford, is concerned with Clifford's career as a publisher, his position in the broadcasting business and his work with such organizations as the Canadian Aid To Russia Fund and the International Press Institute. There are extensive series of editorial correspondence with his brother Victor, to 1953, and subsequently with his editors. The correspondence is arranged chronologically by year and alphabetically within each year.

Subject files: Clifford Sifton, 1927-1976. 30 cm (volumes 11-13).

Reports, memoranda, newspaper articles, speeches, minutes and published material relating to Clifford Sifton's editorial interests and organizational activities, and to Sifton family interests such as the Beauharnois Light Heat and Power Corporation. Arranged alphabetically.

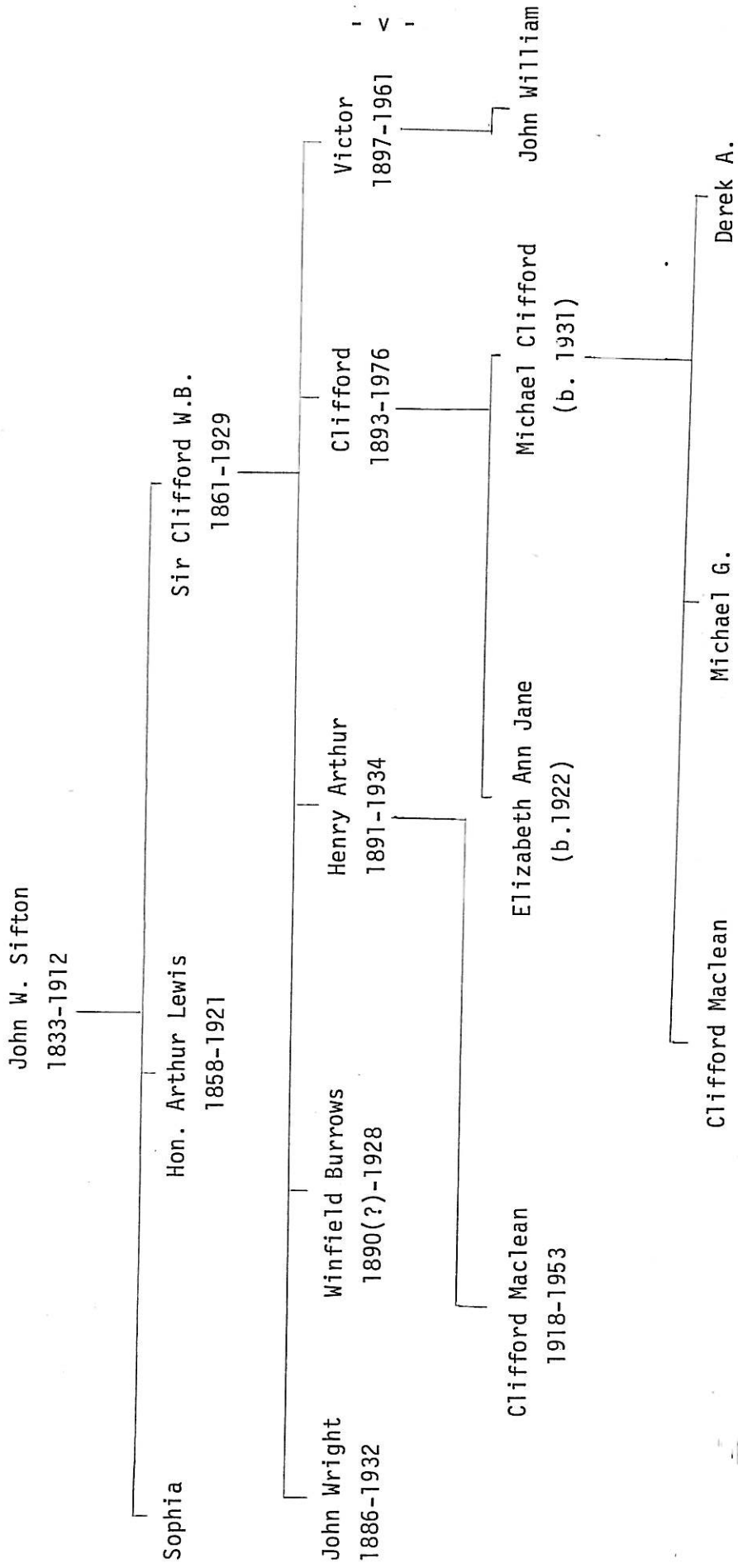
