Jacob Lawrence Cohen was a prominent labour and civil rights lawyer during the 1930's and 1940's. He served as legal counsel for many of the new industrial unions and consequently was involved in most of the key labour-management disputes of the period. During the Depression he defended many left-wing leaders and organizations and he acted on behalf of many of the people interned during World War II. Throughout his career, J.L. Cohen campaigned for progressive social and labour legislation, and in 1943 he left the National War Labour Board, after serving only six months, in protest against the Federal Government's policy on wages and collective bargaining. His career was halted in 1946 when he was convicted on an assault charge and subsequently disbarred. He was re-admitted to the Bar in 1950 but died suddenly four months later.

Finding Aid No. 1044 is a file list, supplemented by a nominal index to the case files. Some publications were transferred to the Archives Library and some photographs were transferred to the National Photography Collection. One handbill has been placed in the horizontal filing cabinet.

Several fragile and oversized items have been removed and placed in the vault. They have been replaced in the collection with xerox copies.

Cases Files, 1927-1949. 9.4 m (volumes 1-47).

Files containing correspondence, legal documents, notes, printed matter, and newspaper clippings pertaining to cases handled by J.L. Cohen. Most of the files deal with labour-management negotiations including arbitration and conciliation, grievances, and government boards and inquiries. There are also files covering the various studies undertaken by Cohen for labour organizations and governments. In addition to specific subject files, there are some general files covering a variety of clients and issues, and some files covering one union or other clients over a period of time. A few files contain only material collected by Cohen for reference purposes.

INTRODUCTION

Following J.L. Cohen's death in 1950, his legal files and personal papers were safeguarded by his daughter, Mrs. Phyllis Clarke. Unfortunately, in the twenty-three years before they were given to the Public Archives of Canada, some boxes of files were severly damaged by water, to the extent that the documents had to be thrown out, and some were lost. For example, 64 files from 1943 are missing, including series on the United Autoworkers, Mine-Mill and the United Electrical Workers. However, many of the missing files from the 1920's and 1930's were removed by Public Archives staff because they pertained to cases of no historical significance, such as estates, divorces, small business matters and petty civil and criminal matters.

In arranging the legal files, the staff of the Public Archives tried to preserve the filing system used in Cohen's office. Many of the documents had fallen out of their file folders and the archivists tried to determine where they belonged. However, it was impossible to be certain of the original location of some documents and undoubtedly there is some mis-filing. Serious errors should be brought to the attention of the Labour Archives Co-ordinator.

The first 30 case files were not numbered when they arrived at the Public Archives. The series labelled "miscellaneous" which includes the personal papers was arranged by the archivists.

The copy of the proceedings of the preliminary hearing of Rex vs. Ivan Bell in connection with the Regina Riot of 1935 (file 2492, vol. 5) is damaged considerably. A useable copy of these proceedings is available in the records of the Saskatchewan Royal Commission into the Regina Riot (MG 9 K2, Reel M-1956).

The run of the <u>Search Light</u>, the paper of the Canadian Seamen's Union, was microfilmed by the Labour Canada Library. The microfilm can be borrowed on inter-library loan from either the Public Archives of Canada or the Labour Canada Library.

An index by name of individual, union, organization and company has been prepared for the case files. The index is included in the finding aid.
