Frederick William Ermatinger, usually known as William (1811-1869) was inspector and superintendant of police in Montreal from 1843 to 1855 and was appointed police magistrate in 1864. The intervening years, 1856 to 1863, he served as field inspector of the active volunteer militia of Canada East.

Finding aid no. 1056 provides a descriptive list of the papers in chronological order.

Letters received by William Ermatinger relating to military affairs and a few items relating to his work as a police magistrate, 1854-1863 (paginated 5477-6259). Formerly part of the Bertrand Collection.

Letters to Ermatinger, as field inspector of the volunteer militia, and papers relating to such military activities as marches, drills, inspections, and the ordering of arms and supplies, 1857-1866 (85 pages); letter to Ermatinger as police magistrate from Sir Alexander Campbell regarding payment to E. Clarke of Sherbrooke for his reports on the Fenian conspiracy, 11 January 1867 (4 pages); letter in French from Sir Narcisse Belleau concerning the case of William Kennedy, 6 May 1867 (3 pages). INTRODUCTION

The collection consists mainly of correspondence received by Lt. Col. William Ermatinger as field inspector of the volunteer militia, 1856-1867, with a few items relating to his work as a police magistrate, 1854-1867.

The finding aid provides a detailed list of the correspondence in chronological order, giving the date, author, subject and page numbers of each item.

The bulk of the collection was acquired with the Collection of Camille Bertrand (MG 24, L 5) and the pagination has been retained (page numbers 5468-6260) except for the additional items, acquired in 1978, which are numbered 1-92. The material is arranged in numerical sequence, commencing with the transferred material (page number 5477).

Records accumulated by other members of the Ermatinger family are to be found in MG 19 A 2, series 1 - 3, and MG 23, G II 3. Genealogical notes on the family are found in MG 19 A 2 series 4 and MG 25 no. 38.
