Bernard Wilson was born in England in 1908. He attended the University of Western Ontario, majoring in economics and political science. In 1944 he became Secretary of the Wartime Labour Relations Board. He joined the Canada Labour Relations Board in 1945 and became Chief Executive Officer in 1954. From 1956 to 1966 he was Director, Industrial Relations Board, Department of Labour. He was appointed Assistant Deputy Minister, Department of Labour and served as Deputy Minister from 1971 until his retirement in November 1973.

Mr. Wilson presented the history of Wartime Labour Relations in 1974 and the remainder in 1978.
