BROUSE FAMILY. Matilda Township, Dundas County, Upper Canada.

Originals, 1783-1893. 71 pages. Finding Aid No. 1064.

George Brouse (1789-1860), merchant of Matilda and one of the original post masters of the province was also at one time a member of the Legislature of Upper Canada. He raised a large family, which settled in the Matilda area in Dundas County, where George's father, Peter Brouse (1763-1810) a United Empire Loyalist, was granted land in 1818. Another member of the family, Nicholas Brouse (1794-1859), of Iroquois Village, served in the war of 1812.

Presented by Mrs. Mary Brouse of Iroquois, Ontario through Mr. George Brouse of Ottawa, Ontario.
